On 18 October 2014:

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. Each of the registrants (or his/her authorized person) must submit the following to The Double Cove Starview Prime (Double Cove Phase 3) Sales Office at 21/F, ONE IFC, Central, Hong Kong (“Double Cove Starview Prime Sales Office”) during the period after the issue of price list to 16 October 2014 (from 11:00 a.m. to 8:00 p.m.) and 17 October 2014 (from 11:00 a.m. to 12:00 noon). The order of registration will not have any impact on the order of priority for selecting the residential property:

- (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
- (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intend(s) to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$150,000 and made payable to “WOO, KWAN, LEE & LO, SOLICITORS & NOTARIES”; and
- (c) a copy of the registrant’s I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).

2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).

3. The balloting will take place at 3:00 p.m. on 17 October 2014 and the balloting will be effected via a computer network. Every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent. The ballot results, including “registration number”, “ballot result priority” and the “check-in timeslot for registrants” will be posted by the Vendor at The Double Cove Starview Prime Sales Office at 6:00 p.m. on 17 October 2014. The opening hours of The Double Cove Starview Prime Sales Office on 17 October 2014 are from 11:00 a.m. to 9:00 p.m. Registrants will not be separately notified of the ballot results.

4. The registrants (if the registrant is a company, then any one of its directors) shall personally attend Double Cove Shopping Arcade (Double Cove Place), No.8 Wu Kai Sha Road, New Territories (“designated venue”) on 18 October 2014 according to the “check-in timeslot for registrants” in the ballot results posted by the vendor. The registrants must bring along their I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, and I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Agent appointed by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot results. Registrants who arrive at the designated venue at any time later than the “check-in timeslot for registrants” assigned in the ballot results on 18 October 2014 shall not be eligible to select the specified residential properties in the order of priority according to the ballot result priorities.
5. Before entering into the Preliminary Agreement for Sale and Purchase in respect of any specified residential property, the registrant(s) may notify the Vendor on spot to add the number of purchaser(s), provided that such additional purchaser(s) must be the immediate family member(s) of the registrant(s) (only parents, spouses and children) and bring along with the relevant original valid supporting document(s) as a proof to the satisfaction of the Vendor.
6. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection without interest by the registrant (or his/her authorized person) at The Double Cove Starview Prime Sales Office during 19 October 2014 to 20 October 2014 (from 11:00 a.m. to 9:00 p.m.). The registrant must bring along the I.D. Card(s) or Passport(s) of the registrant (or a copy of the I.D Card(s) or Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate or Certificate of Incorporation of the Registrant, the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the I.D Card or Passport of the authorized person.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served basis.

1. 登記人(或其獲授權人士)須於價單發出後至2014年10月16日(上午11時至下午8時)及2014年10月17日(上午11時至中午12時)期間到香港中環國際金融中心一期21樓迎海·星灣御(迎海第三期)售樓處(下稱：迎海·星灣御售樓處)遞交。登記次序不會影響揀選住宅物業的優先次序：
 - (a)已填妥及由登記人簽署的購樓意向登記表格，每位登記人只可遞交1份購樓意向登記，重複遞交將不會受理；
 - (b)購樓意向登記須附有本票，本票的數目須與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟該住宅物業數目不能多於2個。每張本票金額為港幣\$150,000及抬頭人須為「胡關李羅律師行」；及
