Balloting will be used to determine the order of priority. Details are as follows.</li> <li>2. On the date of the sale, an interested person who has already submitted a Registration of Intent* (a “<b>Registrant</b>”) shall attend the Sales Office in person between 9:00 a.m. and 10:30 a.m.. The Registrant must bring along a copy of Registration of Intent and other items required by the Registration of Intent. The Registrants whose identities have been confirmed and verified by the Vendor shall be eligible for the balloting and each Registrant shall be entitled to only one lot. Registrants who arrive at the Sales Office at any time later than 10:30 a.m. on the date of the</li> </ol>	

sale shall not be eligible for any balloting.

3. The computer balloting will take place at Park Metropolitan Sales Office at 11:00 a.m. on the date of the sale.
4. The Registrants shall proceed to select the residential properties in the order of priority according to the result of the balloting. Where a Registrant has indicated in the Registration of Intent that he/ she intends to purchase more than one residential property, when it is the Registrant's turn to select residential properties, to the extent available, that Registrant may select more than one residential property but not more than the number of residential properties that Registrant indicated in the Registration of Intent.

After the completion of the balloting and selection of the residential properties by the eligible Registrants, the order of priority in the selection of the remaining residential properties will be on a first come first served basis (but the order of priority in the selection of the remaining residential properties among all potential purchasers arriving in the same 5 minutes interval beginning on the hour is to be determined by balloting).

In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person. The Vendor also reserves its right to revise the time of conducting computer balloting in accordance with the process of verification of identities of Registrants or attending other necessary procedures.

First come first served basis. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person.

2013年11月5日（“該出售日期”）：

1. 以抽籤方式決定。詳情如下。
2. 有意購買住宅物業並已遞交購樓意向登記\*之人士（「登記人」）須於該出售日期上午9時至10時30分攜同其購樓意向登記副本及購樓意向登記要求之項目親臨售樓處。經賣方確認並核實身份後，登記人方可享有最終抽籤資格，而每個登記人只可獲一個籌。於上午10時30分後任何時間才到達售樓處的登記人將被取消抽籤資格。
3. 電腦抽籤程序將於該出售日期當天上午11時於售樓處進行。
4. 登記人根據抽籤結果順序揀選住宅物業。倘登記人於購樓意向登記表格中表示意欲購買多於一個住宅物業，當輪到該登記人揀選住宅物業時，如尚餘住宅物業之數目容許，該登記人可揀選多於一個住宅物業，但不能多於該登記人於其購樓意向登記表格中表示意

(i) In addition to copies of specified identification documents, cashiers' order(s) must be submitted together with the Registration of Intent. The number of cashiers' order(s) that a Registrant shall submit is the same as the number of residential property(ies) that the Registrant intends to purchase. The amount of each such cashiers' order shall be HK\$200,000. Each such cashiers' order shall be payable to "Baker & McKenzie".
