- (1) 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。  
Prospective purchasers are advised to refer to the sales brochure for the Development for information on the Development.
- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -  
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated;(ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.
- (2) 成交金額5%於買方簽署買賣合約時繳付。  
5% of purchase price being part payment of Transaction Price shall be paid upon signing of the agreement for sale and purchase.
- (3) 成交金額90%於買方簽署臨時合約後90天內繳付。  
90% of purchase price being balance of Transaction Price shall be paid within 90 days after signing of the preliminary agreement for sale and purchase.

(B)180天現金優惠付款 180-day Cash Payment (照售價減4%) (4% discount from Price)

- (1) 成交金額5%（「臨時訂金」）於買方簽署臨時買賣合約時繳付。  
A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.
- (2) 成交金額5%於買方簽署買賣合約時繳付。  
5% of purchase price being part payment of Transaction Price shall be paid upon signing of the agreement for sale and purchase.
- (3) 成交金額5%於買方簽署臨時買賣合約後60天內繳付。  
5% of purchase price being part payment of Transaction Price shall be paid within 60 days after signing of the preliminary agreement for sale and purchase.

85% of purchase price being balance of Transaction Price shall be paid within 180 days after signing of the preliminary agreement for sale and purchase.

(C) 建築期付款 Stage Payment Plan (照售價 Price)

A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.

5% of purchase price being part payment of Transaction Price shall be paid upon signing of the agreement for sale and purchase.

5% of purchase price being part payment of Transaction Price shall be paid within 60 days after signing of the preliminary agreement for sale and purchase.
- (4) 成交金額5% 於買方簽署臨時買賣合約後120天內繳付。  
5% of purchase price being part payment of Transaction Price shall be paid within 120 days after signing of the preliminary agreement for sale and purchase.
- (5) 成交金額80% 於賣方向買方發出書面通知書可將有關物業之業權轉讓予買方的日期起14天內繳付。  
80% of purchase price being balance of Transaction Price shall be paid within 14 days of the date of written notification to the Purchaser that the Vendor is in a position validly to assign the Property to the Purchaser.

A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.
- (2) 成交金額5% 於買方簽署買賣合約時繳付。  
5% of purchase price being part payment of Transaction Price shall be paid upon signing of the agreement for sale and purchase.
- (3) 成交金額90% 於買方簽署臨時合約後90天內繳付。  
90% of purchase price being balance of Transaction Price shall be paid within 90 days after signing of the preliminary agreement for sale and purchase.

#買方可向獲聘用人指定之融資公司申請第二按揭，主要條款如下：

The Purchaser can apply for the second mortgage through the financing company designated by the Person Engaged, key terms are as follows:

- (a) 買方須出示足夠文件證明每月還款(第一按揭加第二按揭及其他借貸的還款)不超過其每月總入息之半。  
The Purchaser must provide sufficient documents to prove that the total amount of monthly instalment (instalment of the first mortgage plus instalment of the second mortgage plus any other loan repayment) does not exceed 50% of the Purchaser's total monthly income.

All legal documents of the second mortgage must be prepared and executed at the solicitors' firm designated by the Vendor. All incurred expenses shall be paid by the Purchaser.

An extra 7.5% discount from the Price would be offered to the Purchasers.

A Purchaser who signs a preliminary agreement for sale and purchase to purchase any of the residential properties on the 2/F to the 18/F from 28 January 2014 to 28 February 2014 (both dates inclusive) will enjoy a "Park Metropolitan Red Pocket Money" discount in the total value of HK\$238,000.
    - (2) 凡於2014年1月28日至2014年2月28日(包括該兩日)簽署臨時買賣合約購買任何20/F至39/F之住宅物業，買方可享「馬上發財大利是」折扣，總值港幣\$388,000。  
A Purchaser who signs a preliminary agreement for sale and purchase to purchase any of the residential properties on the 20/F to the 39/F from 28 January 2014 to 28 February 2014 (both dates inclusive) will enjoy a "Park Metropolitan Red Pocket Money" discount in the total value of HK\$388,000.

Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the Development  
獲聘用人將在不減損買方於買賣合約下之權利下於將收到買方於發展項目合格證明書或轉讓同意發出日起計的2年內(以較早者計) 所發出的書面通知後，在合理地切實可行的範圍內盡快自費就該物業欠妥之處作出補救。本優惠受相關交易文件條款及條件限制。  
The Person Engaged is prepared to, but not in derogation from the purchaser's rights under the agreement for sale and purchase, at its own cost and as soon as reasonably practicable after its receipt of a written notice served by the purchaser within 2 years from the date of issuance of the certificate of compliance or consent to assign in respect of the Development, whichever is earlier, remedy any defects to the Property. This benefit is subject to the terms and conditions of the relevant transaction documents.

如買方選用賣方指定之代表律師作為買方之代表律師同時處理其正式買賣合約、按揭及樓契等法律文件，賣方同意為買方支付買賣合約及轉讓契兩項法律文件之律師費用。  
If the purchaser appoints the Vendor's solicitors to act on his/her behalf of all legal documents in relation to the purchase, the vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment.  
如買方選擇另聘代表律師作為買方之代表律師處理其正式買賣合約、按揭及樓契等法律文件，買賣雙方須各自負責有關買賣合約及其他轉讓契兩項法律文件之律師費用。  
If the purchaser chooses to instruct his own solicitors to act for him in relation to the purchase, each of the Vendor and purchaser shall pay his own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.
