Prospective purchasers are advised to refer to the sales brochure for the Development for information on the Development.
- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

(B)180天現金優惠付款 180-day Cash Payment (照售價減4%) (4% discount from Price)

A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.

5% of purchase price being part payment of Transaction Price shall be paid upon signing of the agreement for sale and purchase.
- (3) 成交金額90% 於買方簽署臨時合約後90天內繳付。
90% of purchase price being balance of Transaction Price shall be paid within 90 days after signing of the preliminary agreement for sale and purchase.

The Purchaser can apply for the second mortgage through the financing company designated by the Person Engaged, key terms are as follows:

A Purchaser who signs a preliminary agreement for sale and purchase to purchase any unit A on the 2/F to the 18/F or any of the residential properties on the 20/F to the 39/F from 1 March 2014 to 31 March 2014 (both dates inclusive) will enjoy a "Park Metropolitan Home Purchase" discount in the total value of HK\$388,000.

如買方選用賣方指定之代表律師作為買方之代表律師同時處理其正式買賣合約、按揭及樓契等法律文件，賣方同意為買方支付買賣合約及轉讓契兩項法律文件之律師費用。
If the purchaser appoints the Vendor's solicitors to act on his/her behalf of all legal documents in relation to the purchase, the vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment.
如買方選擇另聘代表律師作為買方之代表律師處理其正式買賣合約、按揭及樓契等法律文件，買賣雙方須各自負責有關買賣合約及其他轉讓契兩項法律文件之律師費用。
