At least one individual Purchaser (if the Purchaser is an individual(s)) or at least one director of the Purchaser (if the Purchaser is a corporation) should be a SHKP Club member in order to enjoy the Furniture Coupon Offer for SHKP Club Member.

The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Enquiry relating to the furniture coupon should be directed to the relevant product and service provider.

- (d) 買方須於按買賣合約完成住宅物業買賣交易日後 14 日內，以書面方式向賣方申請新地會會員傢俬禮券優惠。賣方會於收到申請並確認有關資料無誤後的 45 日內通知買方，買方必須在 30 日內前往指定地點領取傢俬禮券。

The Purchaser shall apply to the Vendor in writing for the Furniture Coupon Offer for SHKP Club Member within 14 days after the date of completion of sale and purchase in accordance with the agreement for sale and purchase. The Vendor will notify the Purchaser within 45 days after the Vendor has received the application and duly verified the information. The Purchaser should collect the Furniture Coupon at the designated location within 30 days.

Transitional Loan - Stamp Duty Payment (Applicable only to the Purchaser who is individual or limited company incorporated in Hong Kong with all its shareholder(s) and director(s) being individual(s))

The designated financing company reserves the right of making the final decision of the approval and disapproval of the Transitional Loan.

Standby Second Mortgage Loan

(subject to fluctuation). The final mortgage interest rate will be subject to final approval by the designated financing company.

The maximum second mortgage loan amount shall be 20% of the net purchase price (if the net purchase price is lower than HK\$7 million) or 25% of the net purchase price (if the net purchase price is equal to or higher than HK\$7 million), but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 85% of the net purchase price, or the balance of purchase price payable, whichever is lower. Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate as set out in paragraph (4)(A6)(iii)1.

The maximum tenor of second mortgage loan shall be 20 years or the tenor of first mortgage loan, whichever is shorter.

The Purchaser shall provide sufficient documents to prove his/her/its repayment ability, including but not limited to providing sufficient documents to prove that the total amount of monthly instalment (being the total instalment for repayment of first mortgage loan, second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser and his/her/its guarantor(s) (if any).

First mortgagee bank shall be nominated and referred by the designated financing company and the Purchaser shall obtain a prior consent from the first mortgagee bank to apply for a second mortgage loan.

First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.

All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.

- (i) 買方需就有關第二按揭貸款申請支付港幣\$5,000 不可退還的申請手續費。
The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.
- (j) 買方於決定選用此付款計劃前，敬請先向指定財務機構查詢有關詳情，以上所有優惠(如有)及第二按揭貸款批出與否，指定財務機構有最終決定權。不論第二按揭貸款獲批與否，買方仍須完成購買該住宅物業及繳付該住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company on details before selecting this payment plan. All of the above offers (if any) and the approval or disapproval of the second mortgage loan are subject to the final decision of the designated financing company. The Purchaser shall complete the purchase of the residential property and shall fully pay the purchase price of the residential property irrespective of whether the second mortgage loan is approved or not.

Without derogation from the Purchaser's rights under the agreement for sale and purchase, the Vendor shall at its own cost and as soon as reasonably practicable after receipt of a written notice served by the Purchaser within 3 years from the date of completion of the purchase of the residential property or the date when possession of the residential property is delivered to the Purchaser, whichever is earlier, remedy any defects to the residential property caused otherwise than by the act or neglect of any person. The First 3 Years Maintenance Offer is subject to other terms and conditions.

The Purchaser of a residential property that is marked with a “^” in the price list, who has completed the sale and purchase of the residential property in accordance with the agreement for sale and purchase, will be provided by the Vendor with an “Island Table and Cabinet” currently provided at the residential property free of charge. The “Island Table and Cabinet” will be delivered to the Purchaser together with the residential property on an “as is” condition. No warranty or representation whatsoever is given by the Vendor in any respect of the “Island Table and Cabinet” (including but not limited to the physical state and condition, quality, use and function thereof). The value of “Island Table and Cabinet” is as follows:

When the sale and purchase of all the Privilege Residential Properties purchased using the same Group Registration of Intent is completed in accordance with the relevant agreement(s) for sale and purchase, the Purchaser shall (together with other Purchaser(s) using the same Group Registration of Intent) within 14 days apply to the Vendor in writing for the Privilege Residential Property Cash Rebate. The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

(II) 其他買方

Other Purchaser

就每個並非透過組合購樓意向登記購買的特選住宅物業，買方可獲得相等於其載於買賣合約之樓價 2% 的特選住宅物業現金回贈。

For each of the Privilege Residential Properties purchased **not using Group Registration of Intent**, the Purchaser will be offered a Privilege Residential Property Cash Rebate equal to 2% of its purchase price as stated in the agreement for sale and purchase.

買方須按相關買賣合約完成所有相關住宅物業買賣交易後 14 日內，以書面方式向賣方申請特選住宅物業現金回贈。賣方會於收到申請並確認有關資料無誤後的 45 日內將特選住宅物業現金回贈付予買方。

Within 14 days after the completion of sale and purchase of all the relevant residential properties in accordance with the relevant agreement(s) for sale and purchase, the Purchaser shall apply to the Vendor in writing for the Privilege Residential Property Cash Rebate. The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

If the Purchaser chooses to instruct his/her own solicitors to act for him/her in relation to the agreement for sale and purchase and the assignment, each of the Vendor and the Purchaser shall pay his/her own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.

Flexible Payment Plan

This payment plan is not applicable to Purchasers of houses.

The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

The Purchaser shall apply to the Vendor in writing for the Furniture Coupon Offer for SHKP Club Member within 14 days after the date of completion of sale and purchase in accordance with the agreement for sale and purchase. The Vendor will notify the Purchaser within 45 days after the Vendor has received the application and duly verified the information. The Purchaser should collect the Furniture Coupon at the designated location within 30 days.

The Vendor will notify the Purchaser within 45 days after the Vendor has received the application and duly verified the information. Standby Second Mortgage Loan

(subject to fluctuation). The final mortgage interest rate will be subject to final approval by the designated financing company.

Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate as set out in paragraph (4)(B6)(iii)3 and Early Completion Benefit (if any) as set out in paragraph (4)(B6)(iii)1.

First mortgagee bank shall be nominated and referred by the designated financing company and the Purchaser shall obtain a prior consent from the first mortgagee bank to apply for a second mortgage loan.

First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.

All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.

- (j) 買方於決定選用此付款計劃前，敬請先向指定財務機構查詢有關詳情，以上所有優惠(如有)及第二按揭貸款批出與否，指定財務機構有最終決定權。不論第二按揭貸款獲批與否，買方仍須完成購買該住宅物業及繳付該住宅物業的樓價全數。

The Purchaser is advised to enquire with the designated financing company on details before selecting this payment plan. All of the above offers (if any) and the approval or disapproval of the second mortgage loan are subject to the final decision of the designated financing company. The Purchaser shall complete the purchase of the residential property and shall fully pay the purchase price of the residential property irrespective of whether the second mortgage loan is approved or not.

The First 3 Years Maintenance Offer is subject to other terms and conditions.

No warranty or representation whatsoever is given by the Vendor in any respect of the “Island Table and Cabinet” (including but not limited to the physical state and condition, quality, use and function thereof). The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

(II) 其他買方

Other Purchaser

For each of the Privilege Residential Properties purchased **not using Group Registration of Intent**, the Purchaser will be offered a Privilege Residential Property Cash Rebate equal to 2% of its purchase price as stated in the agreement for sale and purchase.

Within 14 days after the completion of sale and purchase of all the relevant residential properties in accordance with the relevant agreement(s) for sale and purchase, the Purchaser shall apply to the Vendor in writing for the Privilege Residential Property Cash Rebate. The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

Where the preliminary agreement for sale and purchase is signed on or before 31 May 2014, after the Purchaser has completed the sale and purchase of the residential property in accordance with the agreement for sale and purchase, the Purchaser shall be entitled to a Stamp Duty Cash Rebate (“Stamp Duty Cash Rebate”) offered by the Vendor equal to the total amount of 70% of ad valorem stamp duty (including the ad valorem stamp duty calculated with reference to the new rates) and (if applicable) 70% of buyer’s stamp duty chargeable on the agreement for sale and purchase. **However, the Stamp Duty Cash Rebate that will be offered to a Purchaser for each agreement for sale and purchase covering any of the following residential properties (“Privilege Residential Properties”) shall not be higher than 12% of the total purchase price as stated in that agreement for sale and purchase.**

If the Purchaser is unable to timely provide the official receipt(s) for payment of the relevant stamp duty due to the Stamp Duty (Amendment) Bill 2012 and/or the Stamp Duty (Amendment) Bill 2013 not being passed 51 days before the date of completion of the sale and purchase of the residential

property, the application shall be accompanied with the **official receipt(s)** for stamp duty paid and the **solicitors' receipt(s)** for the sum deposited by the Purchaser in accordance with the agreement for sale and purchase with the Vendor's solicitors (as stakeholders) for payment of stamp duty.

Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate as set out in paragraph (4)(C6)(iii)2 and Early Completion Benefit (if any) as set out in paragraph (4)(C6)(iii)1.

All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.

The Purchaser is advised to enquire with the designated financing company on details before selecting this payment plan. All of the above offers (if any) and the approval or disapproval of the second mortgage loan are subject to the final decision of the designated financing company. The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

(II) 其他買方

Other Purchaser

The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

A preliminary deposit equivalent to 5% of the purchase price (“preliminary deposit”) shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase shall be signed by the Purchaser within 5 working days after the date of signing of the preliminary agreement for sale and purchase.

The Purchaser shall make a written application to the designated financing company for a second mortgage loan not less than 60 days before actual date of completion of sale and purchase of the residential property.
- (b) 第二按揭貸款首 12 個月之按揭利率為香港上海滙豐銀行有限公司之港元最優惠利率（『港元最優惠利率』）減 2.5% p.a.，期後之按揭利率以港元最優惠利率加 1% p.a. 計算，利率浮動。最終按揭利率以指定財務機構審批結果而定。
