Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate as set out in paragraph (4)(A13)(iii)1.

The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.

All of the above offers (if any) and the approval or disapproval of the second mortgage loan are subject to the final decision of the designated financing company. The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

(II) 其他買方

Other Purchaser

For each of the Privilege Residential Properties purchased **not using Group Registration of Intent**, the Purchaser will be offered a Privilege Residential Property Cash Rebate equal to 2% of its purchase price as stated in the agreement for sale and purchase.

The Vendor will pay the Privilege Residential Property Cash Rebate to the Purchaser within 45 days after the Vendor has received the application and duly verified the information.

The Purchaser shall apply to the Vendor in writing (together with the following documents) for the Stamp Duty Cash Rebate at least 21 days before the date of completion of the sale and purchase of the residential property. After the Vendor has received the application and duly verified the information, the Vendor will apply the Stamp Duty Cash Rebate to part payment of the balance of the purchase price directly:

 - The application shall be accompanied with the official receipt(s) for payment of all stamp duty payable on the agreement for sale and purchase; or

property, the application shall be accompanied with the **official receipt(s)** for stamp duty paid and the **solicitors' receipt(s)** for the sum deposited by the Purchaser in accordance with the agreement for sale and purchase with the Vendor's solicitors (as stakeholders) for payment of stamp duty.

All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.

 - The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.

The Purchaser is advised to enquire with the designated financing company on details before selecting this payment plan. All of the above offers (if any) and the approval or disapproval of the second mortgage loan are subject to the final decision of the designated financing company.
