The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase :

On 18 February 2014:

Balloting will be used to determine the order of priority.

Persons interested in purchasing any of the specified residential properties (“the registrant”) must follow the procedures below:-

1. A registrant must submit:-

- (a) only one Registration of Intent duly completed and signed by the registrant;
- (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2) for Hong Kong Permanent Residents (“HKPR”) and one (1) for all other cases. Each cashier order shall be in the sum of HK\$150,000 and made payable to “WOO, KWAN, LEE & LO”; and
- (c) a copy of the registrant’s H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate

to 86/F, International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong (“ICC venue”) from the date on which price list no.1 is made available to 16 February 2014 (both days inclusive) during office hours (i.e. from 2:00 p.m. to 9:00 p.m. on Monday to Friday and from 12:00 noon to 9:00 p.m. on Saturday, Sunday and Public Holiday). The closing time for submission of Registration of Intent will be 9:00 p.m. on 16 February 2014.

2. Each registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. Late submission will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable.

3. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).

4. Balloting will take place in batches:

(a) First round balloting (for dividing all registrants into different groups)

- (i) The first round balloting will take place at 2:00 p.m. on 17 February 2014 at the **Riva Shopping Arcade, No.1 Ying Ho Road, New Territories** (“designated venue”) for the purposes of dividing the registrants into different groups. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the ICC venue and the designated venue. Registrants will not be notified separately of such changes.
- (ii) After the first round balloting, the registrants will be divided into groups and the registrants in each group will be eligible to participate in the second round balloting which will take place in batches.
- (iii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the ICC venue and the designated venue, after completion of the first round balloting. Registrants will not be separately notified of the ballot results.
- (iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

(b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting of the different groups of registrants will take place in batches at the **designated venue** at such time(s) as posted by the Vendor pursuant to paragraph 4(a)(iii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue. Registrants will not be notified separately of such changes.

- (ii) Registrants shall attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. For the purpose of verification of identities, registrants must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and the original receipt of the valid Registration of Intent. Registrants who arrive at the designated venue beyond “check-in timeslot for each group” shall not be eligible to participate in the second round balloting.
- (iii) For the purpose of the second round balloting, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void in the same balloting. The number of specified residential property(ies) that the registrant of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant intends to purchase as indicated in that Registration of Intent. The results of the second round balloting, including “registration number” and “ballot result sequence” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
- (iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

5. Immediately after the second round balloting, the registrants shall personally proceed to select and purchase the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence”. However, only those registrants who satisfy the following requirements:-

- (a) Each of the registrant of a valid Registration of Intent is a Hong Kong Permanent Resident(s) (“HKPR”); or
- (b) One or more of the registrant of a valid Registration of Intent is a HKPR who purchases the specified residential property(ies) jointly with one or more close relative (i.e. spouse, parents, children, brothers and sisters) who is/are not HKPR but is/are a registrant of that Registration of Intent

will be entitled to select (but not more than one (1) specified residential properties for the registrant(s) of each Registration of Intent) the following specified residential properties:-

6. If a registrant has successfully selected any of the specified residential properties, the registrant will be offered to view the selected specified residential property(ies) and if the registrant decides to purchase the selected specified residential property(ies), the registrant shall **personally** enter into a Preliminary Agreement for Sale and Purchase of the specified residential property(ies) successfully selected by him/her. Before entering into the Preliminary Agreement for Sale and Purchase, the registrant may notify the Vendor on spot to add any person(s) who is/are close relative(s) of the registrant(s) (i.e. spouse, parents, children, brothers and sisters) as joint purchaser(s) subject to provision of adequate proof to the Vendor’s satisfaction of such relationship and that all the aforesaid persons shall sign the Preliminary Agreement for Sale and Purchase as purchasers personally.

7. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection by the registrant (or his/her authorized person) at the ICC venue during 19 February 2014 to 20 February 2014 (from 2:00 p.m. to 9:00 p.m.). The registrant must bring along the H.K.I.D. Card(s)/Passport(s) of the registrant (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate of the Registrant, the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis and the balloting procedures stated above will not apply to the purchase of such remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

The Vendor reserves the right to close the designated venue at any time if all the specified residential properties have been sold out.

On 19 February 2014 and thereafter:

Subject to the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

The Vendor reserves the right to close the designated venue at any time if all the specified residential properties have been sold out.

2014年2月18日：

以抽籤方式決定選擇住宅物業的次序。

有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 登記人須從價單編號 1 號提供的日期起至 2014 年 2 月 16 日（包括首尾兩日）於辦公時間內(即星期一至五下午 2 時至晚上 9 時及星期六、日及公眾假期中午 12 時至晚上 9 時)，到香港九龍柯士甸道西 1 號環球貿易廣場 86 樓(下稱「ICC 會場」)，
 - (a) 遞交一份已填妥及由登記人簽署的購樓意向登記；
 - (b) 購樓意向登記須附有本票，本票的數目需與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟如登記人為香港永久性居民，該住宅物業數目不能多於 2 個以及如屬其他情況，該住宅物業數目不能多於 1 個。每張本票金額為港幣\$150,000 及抬頭人須為「胡關李羅律師行」；及
 - (c) 登記人的香港身份證/護照及(如適用)商業登記證書副本。

遞交購樓意向登記截止時間為 2014 年 2 月 16 日晚上 9 時。

2. 每名登記人只可登記於一份有效的購樓意向登記，重複的登記人登記將不會被接受，逾期恕不受理。購買意向登記只適用於登記人本人及不能轉讓。
3. 本票將會用作支付購買指明住宅物業的部份臨時訂金。
4. 抽籤將分階段進行：

(a) 第一輪抽籤(將所有登記人分為不同組別)

- (i) 第一輪抽籤程序將於 2014 年 2 月 17 日下午 2 時於新界映河路 1 號爾巒商場(下稱「指定會場」)進行，以將登記人分為不同組別。為了維持指定會場秩序及流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整第一輪抽籤程序的時間和日期。任何第一輪抽籤程序的時間和日期的修改會於 ICC 會場及指定會場公布。登記人將不獲另行通知該等修改。
- (ii) 經過第一輪抽籤後，登記人會被分為不同組別，於不同時段參與分階段進行的第二輪抽籤程序。
- (iii) 第一輪抽籤完成之後，賣方會將第一輪抽籤結果，包括「登記號碼」、「分組結果」及「每組別報到時段」於 ICC 會場及指定會場公布。登記人將不獲另行通知抽籤結果。
- (iv) 如抽籤結果有任何錯誤或遺漏，賣方無須向登記人承擔任何責任。

(b) 第二輪抽籤(決定登記人選購指明住宅物業的優先次序)

- (i) 第二輪抽籤程序將於賣方根據上述第 4(a)(iii)段公布之時間依不同組別於指定會場分階段進行。為了維持指定會場秩序及/或流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整第二輪抽籤程序的時間和日期。任何抽籤程序的時間和日期的修改會於指定會場公布。登記人將不獲另行通知該等修改。
- (ii) 為讓賣方核實登記人身份，登記人須按賣方公布的「每組別報到時段」攜同其香港身份證/護照正本及(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名

單及有效的購樓意向登記收據正本，到達指定會場。於其「每組別報到時段」以外的時間才到達指定會場的登記人將不享有參與第二輪抽籤的資格。

- (iii) 為第二輪抽籤的目的，每一份購樓意向登記可獲分配的籌的數目，相等於登記人於該購樓意向登記內填寫的意欲購買的指明住宅物業數目。當一個籌獲抽中，其相關購樓意向登記的其他籌(如有)於同一次抽籤程序將會取消及作廢。獲中籤的每份購樓意向登記的登記人只可認購不多於購樓意向登記內所填寫的意欲購買的指明住宅物業數目。賣方會將第二輪抽籤結果，包括「登記號碼」及「抽籤結果順序」將於指定會場公布。登記人將不獲另行通知抽籤結果。
- (iv) 如抽籤結果有任何錯誤或遺漏，賣方無須向登記人承擔任何責任。

5. 第二輪抽籤後，登記人立刻根據「抽籤結果順序」親身選購於當時仍可供選擇的指明住宅物業。但只有符合以下要求的登記人，

- (a) 購樓意向登記的每一位登記人均是香港永久居民；或
- (b) 購樓意向登記的其中一位或多於一位登記人是香港永久居民，其與一位或多位非香港永久居民的近親(即配偶、父母、子女、兄弟及姊妹)以聯名方式購買指明住宅物業，而該等近親亦是該購樓意向登記的登記人，

方可有權選擇(但每份購樓意向登記的登記人不可選擇多於 1 個指明住宅物業)以下指明住宅物業：

6. 成功選擇指明住宅物業的登記人將獲安排參觀其所選擇的指明住宅物業，如登記人決定購買其所選擇的指明住宅物業，登記人須親身簽署臨時買賣合約購買其成功選擇的指明住宅物業。在簽署臨時買賣合約前，登記人可即時通知賣方增加買方之人數，惟新加入之買家必須為登記人的近親(即配偶、父母、子女、兄弟及姊妹)，並提供令賣方滿意的足夠證明以證明該關係，並且所有前述人士須以買方身份親自簽署臨時買賣合約。

7. 如登記人並無購入任何指明住宅物業或其購入之指明住宅物業數目未達其於購樓意向登記內所填寫意欲購買之數目，申請人(或其獲授權人士)可於 2014 年 2 月 19 日至 2014 年 2 月 20 日下午 2 時至晚上 9 時內於 ICC 會場辦理取回未使用的本票。登記人須攜同登記人香港身份證/護照正本(如以獲授權人士取回未使用的本票，則須攜同登記人香港身份證/護照副本)及(如適用)登記人之商業登記證書副本、有效的購樓意向登記收據正本、及(如適用)有效的授權書及獲授權人士之香港身份證/護照副本。

當抽籤及合資格人士選購指明住宅物業完畢後，餘下的指定住宅物業(如有)將以先到先得形式發售，而上述的抽籤程序將不適用於購買該等餘下的指定住宅物業。如有任何爭議，賣方保留絕對權力以任何方式(包括抽籤)分配任何指明住宅物業予任何有意購買的人士。
