#### On 8 February 2014 ('the Date of the sale'):

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential property(ies) ('the Registrant(s)') must follow the procedures below:-

- 1. Each of the Registrant(s) must submit the following to the Sales Office from 11:00 a.m. to 8:00 p.m. and if submitted before the Date of the sale, from 11:00 a.m. to 3:00 p.m.:-
  - (a) Only one valid Registration of Intent Form ("Registration of Intent") duly completed and signed by the Registrant. Please note that:-
    - (i) Each Registrant may only submit one Registration of Intent;
    - (ii) Duplicated registration of Registrant will not be accepted;
    - (iii) Late submission will not be accepted;
    - (iv) The Registration of Intent is personal to the Registrant and shall not be transferable;
    - (v) The order of registration will not have any impact on the order of priority for selecting the specified residential property; and
    - (vi) In case of any dispute, the Vendor reserves its right to determine whether

a Registration of Intent is valid and should be included in this balloting;

and

- (b) Cashier's order(s)
  - (i) The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the Registrant(s) intends to purchase as indicated in the Registrant of Intent, but such number of specified residential property(ies) in any event shall not exceed two (2);
