On 21 May 2015:

Any purchaser who purchases any specified residential property(ies) of the development directly through Henderson Property Agency Limited (i.e. other than other estate agents) will be entitled to select all specified residential properties including Flat 8B, Flat 9B, Flat 10B, Flat 8C and Flat 9C (50 units in total). However, any purchaser who purchases any specified residential property(ies) of the development directly through other estate agents (i.e. other than Henderson Property Agency Limited) will only be entitled to select the specified residential properties except Flat 8B, Flat 9B, Flat 10B, Flat 8C and Flat 9C (45 units in total). For the avoidance of doubt, this arrangement will be applicable on 21 May 2015 only.

Balloting

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

- 1. Each of the registrants (or his/her authorized person) must submit the following to AXIS Sales Office at 5/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon ("AXIS Sales Office") during the period from 14 May 2015 to 19 May 2015 (from 11:00 a.m. to 8:00 p.m.) and 20 May 2015 (from 11:00 a.m. to 12:00 noon). The order of registration will not have any impact on the order of priority for selecting the residential property:
 - (a) only one Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intend(s) to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$100,000 and made payable to "YUNG, YU, YUEN & CO."; and
 - (c) a copy of the registrant's I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).
- 2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
- 3. The balloting will take place at 3:00 p.m. on 20 May 2015 and the balloting will be effected via a computer network. Every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent. The ballot results, including "registration number", "ballot result priority" and the "check-in timeslot for registrants" will be posted by the Vendor at AXIS Sales Office at 6:00 p.m. on 20 May 2015. The opening hours of AXIS Sales Office on 20 May 2015 are from 11:00 a.m. to 8:00 p.m. Registrants will not be separately notified of the ballot results.
- 4. The registrants (if the registrant is a company, then any one of its directors) shall personally attend 5/F, Miramar Shopping Centre, Tsim Sha Tsui, Kowloon ("5/F, Miramar Shopping Centre") on 21 May 2015 according to the "check-in timeslot for registrants" in the ballot results posted by the vendor. The registrants must bring along their I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, and I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Agent appointed by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to

the ballot results. Registrants who arrive at 5/F, Miramar Shopping Centre at any time later than the "check-in timeslot for registrants" assigned in the ballot results on 21 May 2015 shall not be eligible to select the specified residential properties in the order of priority according to the ballot result priorities.

First-come-first-served

After the completion of the balloting and the selecting and purchasing of the specified residential properties by the eligible persons in accordance with the above procedures, the order of priority in the selection of all the remaining specified residential properties (if any) will be on a first-come-first-served basis. For the purpose of maintaining order at the sales offices, the vendor reserves the right to allocate a particular specified residential property to a particular interested person and determine to whom a particular specified residential property will be sold by any method (including balloting) in case of any dispute.

On 22 March 2015 and thereafter:

The order of priority in the selection of the remaining specified residential properties including Flat 8B, Flat 9B, Flat 10B, Flat 8C and Flat 9C (if still available) will be on a first-come-first-served basis. Persons interested in purchasing must personally attend the designated place where the sale will take place to purchase the remaining specified residential properties. For the purpose of maintaining order at the sales offices, the vendor reserves the right to allocate a particular specified residential property to a particular interested person and determine to whom a residential property will be sold by any method (including balloting) in case of any dispute.

2015年5月21日:

如買方直接經由「恒基物業代理有限公司」(即非經由其他地產代理公司中介)購買指明住宅物業有權購買所有指明住宅物業,包括 8B 室、9B 室、10B 室、8C 室及 9C 室(合共 50 伙)。但如買方經由其他地產代理公司中介(即非「恒基物業代理有限公司」之地產代理中介)購買指明住宅物業,買方只有權購買 8B 室、9B 室、10B 室、8C 室及 9C 室除外的住宅物業(合共 45 伙)。為免生疑問,本安排只在 2015 年 5 月 21 日適用。

抽籤

以抽籤方式決定優先次序,有意購買該等指明住宅物業的人士或公司(下稱:登記人)須遵從下列程序:-

1. 登記人(或其獲授權人士)須於2015年5月14日至2015年5月19日(上午11時至下午8時)及 2015年5月20日(上午11時至中午12時)期間到九龍尖沙咀美麗華商場5樓 傲形售樓處(下稱:傲形售樓處)遞交。登記次序不會影響揀選住宅物業的優先次序:
