#### 第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

#### 第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

#### 第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及(iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

If the residential property is located on 46/F and 57/F to 60/F, upon signing of the Preliminary Agreement for Sale and Purchase, the Purchaser shall pay the preliminary deposit equivalent to 5 % of purchase price, of which HK\$200,000 must be paid by cashier's order payable to "Ford, Kwan & Company" and the remaining balance must be paid by cheque(s) payable to "Ford, Kwan & Company".

If the residential property is located on 50/F to 56/F, upon signing of the Preliminary Agreement for Sale and Purchase, the Purchaser shall pay the preliminary deposit equivalent to 5 % of purchase price, of which HK\$200,000 must be paid by cashier's order payable to "Philip K.H. Wong, Kennedy Y.H. Wong & Co." and the remaining balance must be paid by cheque(s) payable to "Philip K.H. Wong, Kennedy Y.H. Wong & Co.".

**(C)(B) 180 天付款計劃: (照售價減 7%) 180-day Payment Plan: (7% discount from the Price)**

5% of purchase price (preliminary deposit): shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase. The Formal Agreement for Sale and Purchase shall be signed within 5 working days<sup>+</sup> after signing of the Preliminary Agreement for Sale and Purchase.
2. 樓價 5% (再期訂金): 於買方簽署臨時買賣合約後 5 個工作日<sup>+</sup> 內支付。  
5% of purchase price (further deposit): shall be paid by the Purchaser within 5 working days<sup>+</sup> after signing of the Preliminary Agreement for Sale and Purchase.

5% of purchase price (preliminary deposit): shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase. The Formal Agreement for Sale and Purchase shall be signed within 5 working days<sup>+</sup> after signing of the Preliminary Agreement for Sale and Purchase.
2. 樓價 5% (再期訂金): 於買方簽署臨時買賣合約後 5 個工作日<sup>+</sup> 內支付。  
5% of purchase price (further deposit): shall be paid by the Purchaser within 5 working days<sup>+</sup> after signing of the Preliminary Agreement for Sale and Purchase.

5% of purchase price (further deposit): shall be paid by the Purchaser within 5 working days<sup>+</sup> after signing of the Preliminary Agreement for Sale and Purchase.
