The method to be used, where 2 or more persons are interested in purchasing a particular residential property, to determine the order of priority in which each of those persons may proceed with the purchase:

在有兩人或多於兩人有意購買同一個住宅物業的情況下，將會使用何種方法決定每名該等人士可購買該物業的優先次序：

1. Priority of selection of such specified residential property(ies) will be determined by the number of residential properties intended to be purchased by the interested person and his/her immediate family member(s). A higher priority will be given to the interested person of whom the number of specified residential properties intended to be purchased by him/her and his/her immediate family member(s) is higher. If more than one group of interested person and his/her respective immediate family member(s) intend to purchase the same number of specified residential properties, the priority among such interested person will be determined by balloting.
