“Specified Property” means a residential property in the Development in respect of which a preliminary agreement for sale and purchase has been entered into (and that preliminary agreement has not been terminated for whatever reason as a result of the failure in entering into the agreement for sale and purchase on time). The purchased property may be matched with a Specified Property if the Purchaser of the purchased property is or includes the Purchaser of that Specified Property (or his/her close family member) or any person comprising that Purchaser (or his/her close family member). The Purchaser shall apply to the Vendor in writing for the Family Bonus Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price. The Vendor reserves the final right to decide whether or not such close family member relationship exists. After the Vendor has received the application and duly verified the information, the Vendor will apply the Family Bonus Cash Rebate as part payment of the balance of the purchase price directly. For the avoidance of any doubt, only one 1% Family Bonus Cash Rebate Discount will be offered for each eligible residential property.
