The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

1. General provisions:
一般規定：

1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2 In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person.

1.3 Please refer to “Other matters” below for the meaning of “4-bedroom specified residential property”.

2.1 Balloting will be used to determine the order of priority. Details are as follows.

2.2 The balloting will be divided into 2 rounds applicable to the following 2 groups of persons who have already submitted Registration(s) of Intent (see below) (each a “registrant”):

2.3 The First Round Selection
第一輪揀樓

- (a) A Group A registrant shall attend the part of the additional venue on Level 9 of Fortune Metropolis in person between 9:00 a.m. and 9:15 a.m. (the “First Round Attendance Registration Period”). The Group A registrant must bring along (a) a copy of each of the completed and submitted Registration of Intent, blank cheque(s) and H.K.I.D./passport (for individual registrant) OR (b) a copy of each of its completed and submitted Registration of Intent, blank cheque(s), a copy of Business Registration Certificate, a copy of the most updated annual return of the company and the company chop (for corporate registrant).

已遞交「購樓意向登記」的A組登記人須於出售首日上午9時至上午9時15分（「第一輪報到時段」）攜同(a)其已填寫及已遞交的「購樓意向登記」副本、空白支票及香港身份證或護照(如登記人為個人)或(b)已填寫及已遞交的「購樓意向登記」副本、空白支票、商業登記證副本、公司最近的周年申報表副本及公司印章（如登記人為公司）親臨置富都會9樓之外加會場部分。

- (b) Group A registrants whose identities have been confirmed and verified by the Vendor shall be eligible for the balloting and each Registration of Intent submitted by those registrants whose identities have been so verified shall be allotted with one lot. Group A registrants who arrive at that part of the additional venue at any time after the expiry of the First Round Attendance Registration Period shall not be eligible for any balloting.

A組登記人經賣方確認並核實身份後方可享有最終抽籤資格，而經如此核實身份後的該等登記人已遞交的每份「購樓意向登記」可獲分配一個籌。A組登記人於第一輪報到時段屆滿後才到達該外加會場部分將不獲抽籤資格。

- (c) The balloting for the First Round Selection will take place at or after 9:30 a.m. on the First Date of Sale at the additional venue. The Group A registrants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the result of balloting allocated to the Registrations of Intent, subject to the following terms:

第一輪揀樓之抽籤程序將於出售首日當天上午9時30分或之後於外加會場進行。A組登記人根據該抽籤結果分配予各「購樓意向登記」之順序揀選當時仍可供選擇的指明住宅物業，唯受以下條款限制：

- (i) Only 100 specified residential properties will be sold in the First Round Selection (the “First Round Quota”). Once the number of selected specified residential properties meets First Round Quota or there only remains one unselected specified residential property to meet the First Round Quota or no 4-bedroom specified residential property remains available for selection, the First Round Selection will end and the remaining Group A registrants will cease to be eligible to select any specified residential properties under the First Round Selection.

- (ii) There is no maximum limit in the number of specified residential properties which a Group A registrant may select in the First Round Selection, but a Group A registrant may not select only one specified residential property in the First Round Selection. Where a Group A registrant is, for whatever reason (whether or not relating to the First Round Quota or only one specified residential property remains available for selection or no 4-bedroom specified residential property remains available for selection) not able to select two or more specified residential properties, (at least one of which must be a 4-bedroom specified residential property) that Group A registrant will cease to be eligible to select any specified residential properties in the First Round Selection.

A組登記人於第一輪可揀選之指明住宅物業數目並無上限，唯A組登記人不得於第一輪只揀選一個指明住宅物業。若一A組登記人因任何原因（不論是否關於第一輪限額或僅剩一個指明住宅物業可供揀選或沒有剩餘的4房指明住宅物業可供揀選）未能揀選兩個或以上指明住宅物業，（最少一個必須為4房指明住宅物業）該A組登記人即失去於第一輪揀樓中揀選任何指明住宅物業之資格。

- (iii) For the avoidance of doubt, where a Group A registrant ceases to be eligible to select any specified residential properties in the First Round Selection as aforesaid, that Group A registrant will not be eligible to participate in the Second Round Selection.

2.4 The Second Round Selection

第二輪揀樓

- (a) Those specified residential properties which have not been selected during the First Round Selection, if any, will be allocated to the Second Round Selection. The Vendor will announce (by such means as the Vendor considers appropriate) at the additional venue before balloting for the Second Round Selection as to which specified residential properties have been allocated to the Second Round Selection for the information of the Group B registrants.

未有於第一輪揀樓中被揀選之指明住宅物業（如有）將配置入第二輪揀樓供揀選。賣方會於外加會場在第二輪揀樓抽籤程序之前公布（透過賣方認為合適之方式）配置入第二輪揀樓之指明住宅物業，以供B組登記人參照。

- (b) A Group B registrant shall attend the part of the additional venue at the Atrium on Level 7 of Fortune Metropolis in person between 10:00 a.m. and 11:00 a.m. (the “Second Round Attendance Registration Period”). The Group B registrant must bring along (a) a copy of each of the completed and submitted Registration of Intent, blank cheque(s) and H.K.I.D./passport (for individual registrant) OR (b) a copy of each of its completed and submitted Registration of Intent, blank cheque(s), a copy of Business Registration Certificate, a copy of the most updated annual return of the company and the company chop (for corporate registrant).

已遞交「購樓意向登記」的B組登記人須於出售首日上午10時至上午11時（「第二輪報到時段」）攜同(a)其已填寫及已遞交的「購樓意向登記」副本、空白支票及香港身份證或護照(如登記人為個人)或(b)已填寫及已遞交的「購樓意向登記」副本、空白支票、商業登記證副本、公司最近的周年申報表副本及公司印章（如登記人為公司）親臨置富都會7樓中庭之外加會場部分。

- (c) Group B registrants whose identities have been confirmed and verified by the Vendor shall be eligible for the balloting and each Registration of Intent submitted by those registrants whose identities have been so verified shall be allotted with one lot. Group B registrants who arrive at that part of the additional venue at any time after the expiry of the Second Round Attendance Registration Period shall not be eligible for any balloting.

B組登記人經賣方確認並核實身份後方可享有最終抽籤資格，而經如此核實身份後的該等登記人已遞交的每份「購樓意向登記」可獲分配一個籌。B組登記人於第二輪報到時段屆滿後才到達該外加會場部分將不獲抽籤資格。

- (d) The balloting for the Second Round Selection will take place at or after 11:30 a.m. on the First Date of Sale at the additional venue. The Group B registrants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the result of balloting allocated to the Registrations of Intent.

第二輪揀樓抽籤程序將於出售首日當天上午 11 時30分或之後於外加會場進行。B組登記人根據該抽籤結果分配予各「購樓意向登記」之順序揀選當時仍可供選擇的指明住宅物業。

2.5 The following provisions apply to the selection of specified residential properties under the First Round Selection and also the selection of specified residential properties under the Second Round Selection:

以下條款適用於第一輪揀樓中之指明住宅物業揀選及第二輪揀樓中之指明住宅物業揀選：

- (a) The balloting results, including “registration number” stated on the Registration of Intent and “balloting result priority” will be shown on TV screen or announced by such other means as the Vendor considers appropriate at the additional venue. Registrants will not be separately notified of the balloting results.

抽籤結果（包括購樓意向登記上的「登記號碼」及「抽籤結果次序」）將會顯示於外加會場的電視屏幕或以其他賣方認為合適之方式於外加會場公布。登記人將不獲另行通知抽籤結果。

- (b) The applicable number of cashiers’ order(s) submitted with the Registration of Intent will be encashed to settle part of the preliminary deposit(s) of the specified residential property(ies) purchased (the balance to be paid by cheque(s)) if the registrant shall successfully purchase one or more specified residential properties. If the number of specified residential properties a registrant purchases is more than the number of cashiers’ order(s) submitted, the registrant shall submit on spot one cashiers’ order (of the same payee and amount as a cashiers’ order(s) submitted with the Registration of Intent) in respect of each such extra specified residential property to settle part of the preliminary deposit of that extra specified residential property (the balance to be paid by cheque(s)).

如登記人成功購入一個或以上的指明住宅物業，隨「購樓意向登記」附上適用數量的銀行本票將兌現以支付所購入物業的部份臨時訂金（餘款以支票支付）。倘登記人購入的指明住宅物業數目多於其所遞交之銀行本票數目，登記人須就每一超出之指明住宅物業即場補交一張銀行本票（抬頭人及金額與隨「購樓意向登記」附上之本票相同）以支付該超出之物業的部份臨時訂金（餘款以支票支付）。

- (c) Before entering into the Preliminary Agreement for Sale and Purchase in respect of a specified residential property, the registrant may request the Vendor on spot to add one or more immediate family members of any individual comprising that registrant as joint purchaser(s) provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s).

The order of the submission of a Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. - (a) In addition to copies of specified identification documents, each Registration of Intent shall be submitted together with one to two cashiers' orders. Registrants who intend to purchase one specified residential property shall submit one cashier's order. For those registrants who intend to purchase two or above residential properties, they shall submit two cashier's orders. The amount of cashier's order shall be HK\$100,000. The cashiers' order shall be payable to "DEACONS".

- (c) No more than two Registrations of Intent can be submitted by the same registrant (a registrant here means an individual, a company or a combination of individual(s) and/or company(ies). For the purpose of illustration, (1) a person A; and (2) that person A together with another person B will not be taken as the same registrant).

2.7 After the completion of the First Round Selection and Second Round Selection, the sale of any remaining specified residential properties will be on a first come first served basis. Persons interested in purchasing must personally attend the additional venue. The Vendor does not accept any person interested in purchasing having queued up before the Time of

the Sale on the date concerned.

- 2.8 Prospective purchasers will be offered to view the selected specified residential property(ies), or a comparable residential property if it is not reasonably practicable for the selected specified residential property(ies) to be viewed by the prospective purchasers, before attending the sales office for selection of any of the specified residential properties or entering into the preliminary agreement for sale and purchase. Please refer to paragraph (a) of “Other Matters” below.
