The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

If the purchaser after signing of Preliminary Agreement for Sale and Purchase finally does not need to apply for the “Standby Second Mortgage” under paragraph (4)(iii)(c) above, a cash rebate which is equivalent to 1% of the Net Purchase Price will be paid to the Purchaser provided that the Purchaser shall give a written notice to the Vendor to confirm that the Purchaser will not apply for the Standby Second Mortgage not less than 60 days before the date of full payment of Purchase Price.
