(P-2%), thereafter at Hong Kong Dollar Best Lending Rate (P), subject to fluctuation. The final interest rate will be subject to final approval by the Vendor's designated financing company.
- C) 如買方於提款日起計的38個月內準時並全數清還第一按揭貸款，賣方指定的財務機構將會向買方退還2%之成交金額。
