 The Purchaser is required to provide documents to prove that the financial assets value (net of related credit facilities) (see note below) of the Purchaser and (if any) his/her guarantor(s) shall be at least (if the purchase price is HK\$6,000,000 or below) 30% of the purchase price; or (if the purchase price is over HK\$6,000,000) 20% of the purchase price, and other necessary documents upon request from the designated financing company, including without limitation, credit report and/or banking record.
