In any event, no objection or requisitions whatsoever shall be raised by the Purchaser in respect of the “Island Table and Cabinet”. For the avoidance of doubt, the First 3 Years Maintenance Offer as set out in paragraph (4)(K1)(iii)5 does not apply to the “Island Table and Cabinet”. This offer is subject to other terms and conditions.
