**On 24 September 2016 (“the first date of the sale”)**

**(I) Abstract**

The sale of specified residential properties (“**Specified Residential Properties**”) will be divided into the following 2 sessions (namely Session A and Session B). Any person interested in purchasing any of the specified residential properties (the “**registrant**”) may participate in both Session A and Session B, or only in Session A or Session B.

B	After the completion of Session A, all remaining Specified Residential Properties which are still available for sale including the following units (Session B Units”):  <u>The following units in Tower 1A:</u> 21F, 19F, 17F, 25G, 22G  <u>The following units in Tower 1B:</u> 18G, 17G  <u>The following units in Tower 2:</u> 21E, 20E, 19E, 18E, 21G, 20G, 19G, 18G,	In Session B, registrant may purchase not more than <b>two (2)</b> Specified Residential Properties, provided that not more than <b>one (1)</b> Specified Residential Property is a studio unit.

**(II) Procedures for Session A**

1. Eligible persons interested in purchasing any of the Specified Residential Properties that will be offered to be sold in Session A (“**Bulk Purchase Registrants**”) must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (IV) of this Sales Arrangements.

2. A Bulk Purchase Registrant must submit the following:-

- (a) only one Bulk Purchase Registration of Intent duly completed and signed by the Bulk Purchase Registrant;
- (b) Bulk Purchase Registration of Intent shall be accompanied with cashier orders. The number of cashier orders shall be equal to the number of Specified Residential Properties which the Bulk Purchase Registrant intends to purchase as indicated in the Bulk Purchase Registration of Intent, but such number of residential properties in any event shall not exceed 6. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”; and
- (c) a copy of the Bulk Purchase Registrant’s H.K.I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to the WTC Venue after relevant price lists of the Specified Residential Properties are made available till 3:00 p.m. on 23 September 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday except that on 23 September 2016 the office hours shall be from 11:00 a.m. to 3:00 p.m.). The closing time for submission of Bulk Purchase Registration of Intent will be 3:00 p.m. on 23 September 2016. Late submission or submission outside the office hours will not be accepted.

3. (a) On the first date of the sale, the Bulk Purchase Registrant who holds a valid Bulk Purchase Registration of

Intent (if the Bulk Purchase Registrant comprises corporation, then all directors of that corporation) shall **personally** attend the WTC G/F Venue between 10:00 a.m. and 10:15 a.m.. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of G/F of **wtc more** and/or Room 2504-06, Room 3506 and Room 3604, World Trade Centre, 280 Gloucester Road, Causeway Bay, Hong Kong (collectively the “**Additional WTC Venues**”) to accommodate some of the Bulk Purchase Registrants by making announcement at the WTC G/F Venue, WTC Venue and the Additional WTC Venues.

- (b) For the purpose of verification of identity, the Bulk Purchase Registrant must bring along the original receipt of the valid Bulk Purchase Registration of Intent and his/her original H.K.I.D. Card(s)/Passport(s) or (if applicable) a copy of Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of the director(s). Bulk Purchase Registrants who arrive at the WTC G/F Venue or (if directed by the Vendor) the Additional WTC Venues beyond 10:15 a.m. on the first date of the sale shall not be eligible to participate in this Session.
- (c) (If the Bulk Purchase Registrant comprises corporation) if after the submission of a Bulk Purchase Registration of Intent there is any change in the board of directors of the corporation, its Bulk Purchase Registration of Intent shall become invalid immediately and the Bulk Purchase Registrant shall not be eligible to participate in this Session.

4. After verification of the identity of Bulk Purchase Registrants by the Vendor,

- (a) The order of priority for selection of the Specified Residential Properties in Session A will be determined by balloting which will take place at the WTC Venue.
- (b) For the purpose of balloting, every valid Registration of Intent shall be allotted one lot. The results of the balloting, including “registration number” and “ballot result sequence”, will be announced and/or posted up at the WTC Venue and the Additional WTC Venues (if applicable). Bulk Purchase Registrants will not be separately notified of the ballot results.
- (c) Bulk Purchase Registrants shall **personally** select the Specified Residential Properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time. A Bulk Purchase registrant who leaves the WTC Venue and/or the Additional Venues (if applicable) while his/her/their/its group is in sessions for selecting and purchasing specified residential properties may be disqualified for participating in selecting and purchasing the specified residential properties and his/her/their/its order of priority shall lapse immediately.
- (d) The Bulk Purchase Registrants shall **in compliance with the rules set out in the Abstract in Section (I) above** select and purchase the Specified Residential Properties, otherwise his/her/its/their order of priority shall lapse automatically and he/she/it/they will no longer be eligible to participate in Session A.
- (e) If the number of Specified Residential Properties the Bulk Purchase Registrant purchases exceeds the number of cashier orders submitted with the Bulk Purchase Registration of Intent, the Bulk Purchase Registrant shall submit on spot to the Vendor one cashier order for each extra Specified Residential Property. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”.
- (f) If the Bulk Purchase Registrant has successfully selected Specified Residential Properties in compliance with the rules set out in the Abstract in Section (I), the Bulk Purchase Registrant shall **personally** enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected Specified Residential Properties.
- (g) Prior to the signing of the Preliminary Agreement(s) for Sale and Purchase, the Bulk Purchase Registrant may notify the Vendor on spot to add and/or delete name(s) of individual(s) subject to the following:
  - (i) the Bulk Purchase Registrant will not be allowed to first delete and then add the name(s) of individual(s) to sign the Preliminary Agreement for Sale and Purchase;
  - (ii) if a Bulk Purchase Registrant wishes to add any name(s) of individual(s), then prior to adding of any name(s) of individual(s) all the individual(s) comprised in the Bulk Purchase Registrant must be **direct family member(s)** (i.e. spouse, parents and children) of each other and the additional individual(s) must be the **direct family member(s)** of **ALL** the individual(s) comprised in the Bulk Purchase Registrant and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final;
  - (iii) if a Bulk Purchase Registrant wishes to delete any name(s) of individual(s), then prior to deletion of

any name(s) of individual(s) all the individual(s) comprised in the Bulk Purchase Registrant must be the **close family member(s)** (i.e. spouse, parents, children, brothers, sisters, grandparents and grandchildren) of each other and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.

All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the Bulk Purchase Registrant's request to add and/or delete the name(s) of any individual(s).

5. If at any time the remaining Specified Residential Property(ies) available for selection and purchase is less than 2, Session A will end and the remaining Specified Residential Property(ies) will be offered for sale in Session B.
6. If at any time the remaining Specified Residential Property(ies) the saleable area thereof is or above 429 sq. ft available for selection and purchase is less than 1, Session A will end and the remaining Specified Residential Property(ies) will be offered for sale in Session B.

(III) Procedures for Session B

7. Eligible persons interested in purchasing any of the Specified Residential Properties that will be offered to be sold in Session B must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (III) and (IV) of this Sales Arrangements.
8. The Vendor may postpone the commencement of Session B pending completion of Session A. Registrants will not be separately notified of such change.
9. A registrant must submit the following:-
  - (a) only one Registration of Intent duly completed and signed by the registrant;
  - (b) Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of Specified Residential Property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed 2. Each cashier order shall be in the sum of HK\$100,000 and made payable to "WOO KWAN LEE & LO"; and
  - (c) a copy of the registrant's H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to the WTC Venue after relevant price lists of the Specified Residential Properties are made available till 3:00 p.m. on 23 September 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday except that on 23 September 2016 the office hours shall be from 11:00 a.m. to 3:00 p.m.). The closing time for submission of Registration of Intent will be 3:00 p.m. on 23 September 2016. Late submission or submission outside the office hours will not be accepted.

10. Balloting:
  - (a) On the first date of the sale, the registrant who holds a valid Registration of Intent (if the registrant comprises corporation, then all directors of that corporation) shall **personally** attend the WTC G/F Venue between 2:30 p.m. and 2:50 p.m.. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the Additional WTC Venues to accommodate some of the registrants by making announcement at the WTC G/F Venue, WTC Venue and the Additional WTC Venues.
  - (b) For the purpose of verification of identity, registrants must bring along the original receipt of the valid Registration of Intent and his/her/their original H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of the director(s). Registrants who arrive at the WTC G/F Venue or (if directed by the Vendor) the Additional WTC Venues beyond 2:50 p.m. on the first day of the sale shall not be eligible to participate in the balloting.
  - (c) (If the registrant comprises corporation) if after the submission of Registration of Intent there is any change in the directorship of the corporation, the Registration of Intent shall become invalid immediately and the registrant shall not be eligible to participate in this Session.
  - (d) After verification of the identity of the registrants by the Vendor, the order of priority for selection of the Specified Residential Properties in Session B will be determined by balloting which will take place at the WTC Venue. The Vendor reserves the right at any time, for the purposes of maintaining order at the WTC Venue and/or facilitating smooth operation of the balloting procedures, to adjust the time and date of the

balloting. Any changes to the time and date of the balloting will be posted at the WTC Venue and the Additional WTC Venues (if applicable). Registrants will not be notified separately of such changes.

- (e) For the purpose of balloting, every valid Registration of Intent shall be allotted one lot. The results of the balloting, including “registration number” and “ballot result sequence” will be announced and/or posted by the Vendor at the WTC Venue and the Additional WTC Venues (if applicable). Registrants will not be separately notified of the ballot results. A registrant who leaves the WTC Venue and/or the Additional Venues (if applicable) while his/her/their/its group is in sessions for selecting and purchasing specified residential properties may be disqualified for participating in selecting and purchasing the specified residential properties and his/her/their/its order of priority shall lapse immediately.
11. (a) Immediately after the balloting, registrants shall **personally** select the Specified Residential Properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time.
- (b) The registrants shall **in compliance with the rules set out in the Abstract in Section (I) above** select and purchase a Specified Residential Property(ies), otherwise his/her/its/their order of priority shall lapse automatically and he/she/it/they will no longer be eligible to participate in this Session B.
- (c) If the number of Specified Residential Properties the Registrant purchases exceeds the number of cashier orders submitted with the Registration of Intent, the Registrant shall submit on spot to the Vendor one cashier order for each extra Specified Residential Property. Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”.
- (d) If the registrant has successfully selected a Specified Residential Property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant shall **personally** enter into one or two Preliminary Agreement(s) for Sale and Purchase of the selected Specified Residential Property(ies).
- (e) Prior to the signing of the Preliminary Agreement(s) for Sale and Purchase, the registrant may notify the Vendor on spot to add name(s) of individual(s), provided that the additional individual(s) must be the **direct family member(s)** (i.e. spouse, parents and children) of **ALL** the individual(s) comprised in the registrant and subject to the provision of adequate proof of such relationship to the Vendor’s satisfaction whose determination shall be final. All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant’s request to add any the name(s) of any individual(s).

(IV) General Procedures

12. The following apply to registration:-
- (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Bulk Purchase Registration of Intent / Registration of Intent. Duplicated registration in a Session will not be accepted.
- (b) The Bulk Purchase Registration of Intent / Registration of Intent is personal to the registrant and shall not be transferable.
- (c) The order of submission of the Bulk Purchase Registration of Intent / Registration of Intent will not have any impact on the order of priority for selecting the Specified Residential Properties.
- (d) In case of dispute, the Vendor reserves its right to determine whether a Bulk Purchase Registration of Intent / Registration of Intent is valid and should be included in balloting.
- (e) (If the registrant comprises corporation) if after the submission of the Bulk Purchase Registration of Intent / Registration of Intent, there is any change in the directorship of the corporation, the Bulk Purchase Registration of Intent / Registration of Intent shall become invalid immediately and the registrant shall not be eligible to participate in Session A and Session B.
13. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the Specified Residential Property(ies).
14. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.
15. If a registrant has not purchased any Specified Residential Property, his/her/its/their unused cashier order(s) will be available for collection by the registrant (or his/her/its/their authorized person) at the WTC Venue from 25 September 2016 to 2 October 2016 during office hours (i.e. from 11:00 a.m. to 7:00 p.m. everyday). The registrant must bring along his/her/their H.K.I.D. Card(s)/Passport(s) (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if

unused cashier order(s) is/are collected by authorized person), (if applicable) copy of Business Registration Certificate, the original receipt of valid Bulk Purchase Registration of Intent / Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.

16. After the completion of the balloting and selection of the Specified Residential Properties by the eligible persons in accordance with the above procedures, the remaining Specified Residential Properties (if any) will be sold on a first come first served basis to any person interested in purchasing. In case of any dispute, the Vendor reserves its absolute right to allocate any Specified Residential Properties to any person interested in purchasing by any method (including balloting).
17. The Vendor reserves the right to close the WTC G/F Venue, WTC Venue and the Additional WTC Venues (if applicable) at any time if all the Specified Residential Properties have been sold out.
18. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 8:00 p.m. on the date on which Bulk Purchase Registration of Intent / Registration of Intent may be submitted and/or at any time between the hours of 7:00 a.m. and 11:00 p.m. on the first date of the sale, then, for the safety of the registrants and the maintenance of order at the WTC G/F Venue, WTC Venue and/or the Additional WTC Venues (if applicable), the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Bulk Purchase Registration of Intent / Registration of Intent and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the WTC G/F Venue, WTC Venue and/or the Additional WTC Venues (if applicable). Details of the arrangement will be posted by the Vendor on the website (<http://www.limegala.hk>) designated by the Vendor for the Development. Registrants will not be notified separately of the arrangement.

**On 25 September 2016 and thereafter:**

19. Subject to the completion of the selecting and purchasing of the Specified Residential Properties by eligible persons in accordance with the above procedures, the remaining Specified Residential Properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining Specified Residential Properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining Specified Residential Properties to any person interested in purchasing by any method (including balloting).
20. The Vendor reserves the right to close the WTC Venue (as the case may be) at any time if all the Specified Residential Properties have been sold out, provided that the WTC Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 15 above.
21. If the Vendor postpones the first date of the sale to such other date pursuant to this Sales Arrangements, the subsequent dates of sale will be postponed accordingly.
22. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 7:00 p.m. on any date of sale (other than the first date of the sale), for the safety of the registrants and the maintenance of order at the WTC Venue (as the case may be), the Vendor reserves its absolute right to close the WTC Venue. ## (II) 第 A 節的程序

1. 有意購買任何在第 A 節出售的指明住宅物業的合資格人士(下稱「量購登記人」)須遵從本銷售安排第(I)部份的摘要列出的規則及第(II)及(IV)部份指定的程序。
