On 27 September 2016 (“the first date of the sale”)

Section (I) - Submission of Registration of Intent

Balloting will be used to determine the order of priority in selecting the specified residential properties. Any person interested in purchasing any of the specified residential properties (“**the registrant**”) must follow the procedures below:-

1. A registrant must **personally** submit the following:-

- (a) only one Registration of Intent duly completed and signed by the registrant;
- (b) the Registration of Intent shall be accompanied with cashier order(s) each in the sum of HK\$100,000 and made payable to “**WINSTON CHU & CO.**”. The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent;
- (c) a copy of the registrant’s H.K.I.D. Card(s)/Passport(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary

to the ICC Venue after the relevant price list(s) of the specified residential properties are made available till 27 September 2016 (both dates inclusive) during office hours (from 2:00 p.m. to 8:00 p.m. on Mondays to Fridays and from 12:00 noon to 8:00 p.m. on Saturdays and Sundays on or before 26 September 2016 and from 12:00 noon to 2:00 p.m. for 27 September 2016). The closing time for submission of Registration of Intent will be 2:00 p.m. on 27 September 2016. Late submission or submission outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the registrant will be given a receipt of Registration of Intent.

Section (II) - Procedures for Balloting

2. For the purpose of verification of identity, the registrants (if the registrant is a corporation, then all directors of that corporation) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and the original receipt of Registration of Intent and personally attend the ICC Venue during 7:00 p.m. and 7:45 p.m. (“the check-in timeslot”) on the first date of sale.
3. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the lobby on 3/F and/or 10/F and/or 22/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the “**Additional Venues**”) to accommodate some of the registrants by making announcement and/or posting notice(s) at the ICC Venue and the Additional Venues. Registrants who arrive at the ICC Venue or (if directed by the Vendor) the Additional Venues beyond the check-in timeslot shall not be eligible to participate balloting.
4. The order of priority for selection of the specified residential properties will be determined according to the balloting which will take place at or after 7:45 p.m. on the first date of sale at the ICC Venue. All valid Registrations of Intent of registrants attending within the check-in timeslot will be included in the balloting. In case of dispute, the Vendor reserves the right to determine whether a Registration of Intent is valid and should be included in the balloting. Before the balloting takes place, the registrants shall be divided into two groups: the first group consists of registrants comprising individual(s) only; and the second group consists of the remaining registrants. **Registrants in the first group will have priority over registrants in the second group in the selection of the specified residential properties.** The Vendor shall carry out the balloting for the first group and the second group respectively.
5. Every Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent. Once a lot allocated to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and treated as null and void in the same balloting. The number of specified residential property(ies) that the registrant of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant intends to purchase as indicated in the Registration of Intent. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting. Any changes to the time and date of the balloting will be posted at the ICC Venue. Registrants will not be notified separately of such changes. The ballot result, including “registration number” and “ballot result sequence”, will be announced at the ICC Venue and (if applicable) the Additional Venues. Registrants will not be separately notified of the ballot results.

6. After the balloting, registrants shall proceed to select and purchase the specified residential properties in the following manner:-
- (a) Registrants (if the registrant is a corporation, then **all of its directors**) shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time.
 - (b) A registrant may only select and purchase not more than the number of specified residential properties which he/she/it intends to purchase as indicated in the Registrant of Intent.
7. If a registrant has successfully selected specified residential property(ies), the registrant shall **personally** enter into preliminary agreement(s) for sale and purchase of the selected specified residential properties.
- (a) Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential property(ies), the registrant may request the Vendor on spot to add his/her close relative(s) as joint purchaser(s) and/or delete the registrant’s name from the preliminary agreement(s) for sale and purchase in accordance with the requirements specified under paragraph 11 below.
 - (b) Not more than **two (2)** selected specified residential properties may be included in each preliminary agreement for sale and purchase.
 - (c) If a registrant wishes to choose “(E2) 70% AVD & BSD Flexible Payment Plan” under the relevant price list(s) for the Phase for the selected specified residential property(ies), each of such specified residential property(ies) must be one of the **first 15** specified residential properties selected (irrespective of whether or not such 15 specified residential properties are eventually purchased by anyone) in accordance with the method specified in this Sales Arrangements.

Section (III) - General Provisions

8. The following apply to registration :-
- (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent. Duplicated registration will not be accepted.
 - (b) The Registration of Intent is personal to the registrant and shall not be transferable.
 - (c) The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties.
 - (d) (For corporate registrant) If after the submission of Registration of Intent, there is any change in the composition of the board of directors of the corporation, then the relevant Registration of Intent shall become invalid immediately and the registrant **shall not be eligible to participate in the balloting.**
 - (e) In case of dispute, the Vendor reserves its right to determine whether a registrant is eligible to participate in the balloting and whether a Registration of Intent is valid and should be included in balloting.
9. Arrangement on cashier order(s) :-
- (a) The cashier order(s) submitted in accordance with Section (I) above will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies). The balance of the preliminary deposit for the purchase of the specified residential property(ies) may be paid by personal cheque(s) upon signing of the preliminary agreement for sale and purchase.
 - (b) If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, the **unused cashier order(s)** will be available for collection by the registrant (or his/her/their authorized person) at the ICC Venue from **28 September 2016 (from 2:00 p.m. to 8:00 p.m.) and 29 September 2016 (from 2:00 p.m. to 8:00 p.m.)**. The registrant must bring along his/her/their H.K.I.D. Card(s)/Passport(s) (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by authorized person), (if applicable) copy of Business Registration Certificate, the original Receipt and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.

10. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.
11. The following apply to signing of preliminary agreement for sale and purchase :-
- (a) “**close relative(s)**” means spouse, parents, children, brothers and sisters of the registrant.
 - (b) If the registrant comprises individual(s) and purchases **one (1)** specified residential property: before signing the preliminary agreement for sale and purchase, such registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (c) If the registrant comprises individual(s) and purchases **two (2)** specified residential properties and the registrants requests to have **one (1) preliminary agreement for sale and purchase** for all those properties: before signing the preliminary agreement for sale and purchase, the registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (d) If the registrant comprises individual(s) and purchases **two (2)** specified residential properties and the registrants requests to have **more than one (1) preliminary agreement for sale and purchase** for those properties :-
 - (i) Before signing the preliminary agreement for sale and purchase in respect of the **first** specified residential property, the registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (ii) Before signing the preliminary agreement for sale and purchase in respect of the **second** specified residential property, the registrant may request the Vendor on spot to :-
 - (1) add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers; or
 - (2) add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as purchaser(s), and delete the registrant’s name from the preliminary agreement for sale and purchase

provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (e) All the person(s) signing the preliminary agreement for sale and purchase must sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant’s request to add and/or delete any individual(s).
12. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing, provided that not more than **two (2)** selected specified residential properties may be included in each preliminary agreement for sale and purchase. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting). For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase on a first come first served basis and there is no restriction on choosing “(E2) 70% AVD & BSD Flexible Payment Plan” under the relevant price list(s) for the Phase for the selected specified residential property(ies).
13. The Vendor reserves the right to close the ICC Venue and (if applicable) the Additional ICC Venues at any time if all the specified residential properties have been sold out.
14. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 4:00 p.m. and 10:00 p.m. on any date on which the Registration of Intent may be submitted and/or the first date of the sale, then,

for the safety of the registrants and the maintenance of order at the ICC Venue and/or (if applicable) the Additional ICC Venues, the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent and/or the first date of the sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the ICC Venue and/or (if applicable) the Additional ICC Venues. Details of the arrangement will be posted by the Vendor on the website (www.grandyoho.com.hk) designated by the Vendor for the Phase. Registrants will not be notified separately of the arrangement.

On 28 September 2016 and thereafter:

15. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing, provided that not more than **two (2)** selected specified residential properties may be included in each preliminary agreement for sale and purchase. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting). For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase on a first come first served basis and there is no restriction on choosing "(E2) 70% AVD & BSD Flexible Payment Plan" under the relevant price list(s) for the Phase for the selected specified residential property(ies).
16. The Vendor reserves the right to close the ICC Venue at any time if all the specified residential properties have been sold out, provided that the ICC Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 9(b) above.
17. If the Vendor postpones the first date of the sale to such other date pursuant to paragraph 14 above, the subsequent dates of sale will be postponed accordingly.
18. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 8:00 p.m. on any date of sale (other than the first date of the sale), for the safety of the purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to close the ICC Venue. Details of the arrangement will be posted by the Vendor on the website (www.grandyoho.com.hk) designated by the Vendor for the Phase.

2016年9月27日(下稱「出售首天」):

第(I)部分 - 遞交購樓意向登記

以抽籤方式決定選擇指明住宅物業的次序。有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 登記人須從指明住宅物業的相關價單提供的日期起至 2016 年 9 月 27 日(包括首尾兩日)於辦公時間內(即 2016 年 9 月 26 日或之前的星期一至五下午 2 時至晚上 8 時、星期六及日中午 12 時至晚上 8 時及 2016 年 9 月 27 日的中午 12 時至下午 2 時)親身到 ICC 會場遞交：
 - (a) 一份已填妥及登記人簽署的購樓意向登記；
 - (b) 購樓意向登記須附有本票，每張本票金額為港幣\$100,000 及抬頭人須為「徐嘉慎律師事務所」。本票的數目需與登記人於購樓意向登記內填寫的意欲購買的指明住宅物業數目相同；及
 - (c) 登記人的香港身份證／護照及（如適用）商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。

遞交購樓意向登記截止時間為 2016 年 9 月 27 日下午 2 時。逾期遞交或在辦公時間以外遞交的恕不受理。登記人在完成本段的程序後將會獲得一張購樓意向登記的收據(下稱「收據」)。

第(II)部分 - 抽籤的程序

2. 為讓賣方核實登記人身份，登記人(如登記人為公司，則該公司的**所有董事**)須於出售首天晚上 7 時至晚上 7 時 45 分內(下稱「報到時段」)親身攜同其香港身份證／護照正本及(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單及購樓意向登記的收據正本，到達 ICC 會場。

3. 賣方可基於流程、效率、方便、安全及／或其他便利抽籤程序的原因使用香港九龍柯士甸道西 1 號環球貿易廣場 3 樓大堂及／或 10 樓及／或 22 樓(以下統稱「外加會場」)以容納部份登記人，並於 ICC 會場及外加會場作出公布及／或貼出告示。於「報到時段」以外的時間才到達 ICC 會場或(如賣方指示)外加會場的登記人將不享有參與抽籤的資格。
4. 登記人揀選指明住宅物業的優先次序將以抽籤方式決定。抽籤程序將於出售首天晚上 7 時 45 分或之後於 ICC 會場進行。所有於報到時段內到達的登記人的有效的購樓意向登記會被納入是次抽籤。如有爭議，賣方保留權利決定購樓意向登記是否有效及是否應被納入是次抽籤。在抽籤進行之前，登記人將被分成兩組：第一組包括僅由個人組成的登記人；及第二組包括餘下的登記人。**第一組的登記人將會優先於第二組的登記人揀選指明住宅物業。**賣方將會分別為第一組及第二組進行抽籤。

6. 抽籤完結後，登記人須根據下述方式揀選指明住宅物業：
 - (a) 登記人(如登記人為公司，則該公司**所有董事**)須根據「抽籤結果順序」有秩序地及於合理時間內**親身**選購指明住宅物業於當時仍可供揀選的指明住宅物業。
 - (b) 登記人可選購的指明住宅物業數目不可多於其購買意向登記內表明意欲購買的指明住宅物業數目。
7. 登記人成功選擇指明住宅物業後，須就已揀選的指明住宅物業**親身**簽署臨時買賣合約。
 - (a) 在簽署已揀選的指明住宅物業的臨時買賣合約前，登記人可根據下述第 11 段的規定即時向賣方要求加入其**近親**以共同簽署臨時買賣合約及／或從臨時買賣合約刪除登記人的名字。
 - (b) 每張臨時買賣合約不可涵蓋多過 **2 個**已揀選的指明住宅物業。
 - (c) 如登記人意欲為其已揀選的指明住宅物業選擇期數的相關價單中的「(E2) 70% AVD & BSD 靈活付款計劃」，每個該等指明住宅物業須為**首 15 個**根據本銷售安排內的指定方式被揀選的指明住宅物業(不論該等 15 個指明住宅物業最終有否被任何人購買)。

第(III)部分 - 一般程序

8. 以下條款適用於登記：
 - (a) 每一個人或每一間公司(不論單獨或與他方聯名)只可登記於一份有效的購樓意向登記。重複的登記將不會被接受。
 - (b) 購樓意向登記只適用於登記人本人及不能轉讓。
 - (c) 遞交購樓意向登記的次序不會影響揀選指明住宅物業的優先次序。
 - (d) (如登記人為公司) 如果在遞交購樓意向登記後，公司有任何董事會成員的變更，其相關的購樓意向登記將立即變成無效，登記人**將不享有參與抽籤的資格**。
 - (e) 如有爭議，賣方保留權利決定登記人是否有資格參與抽籤及購樓意向登記是否有效及是否應被納入抽籤。

9. 關於本票的安排：
- (a) 根據上述第(D)部分遞交的本票將會用作支付購買指明住宅物業的部份臨時訂金。購買指明住宅物業的臨時訂金的餘額可於簽署臨時買賣合約時以支票支付。
- (b) 如登記人並無購入任何指明住宅物業或其購入之指明住宅物業數目未達其於購樓意向登記內所填寫意欲購買之數目，可於 **2016年9月28日(下午2時至晚上8時)**及 **2016年9月29日(下午2時至晚上8時)**親臨 ICC 會場辦理取回**未使用的本票**。登記人必須攜同登記人香港身份證／護照正本(如以獲授權人士取回未使用的本票，則須攜同登記人香港身份證／護照副本)、(如適用)商業登記證書副本、收據正本及(如適用)有效的授權書及獲授權人士之香港身份證／護照副本。
10. 如抽籤結果有任何錯誤或遺漏，賣方毋須向登記人承擔任何責任。
11. 以下條款適用簽署臨時買賣合約：
- (a) 「**近親**」指登記人的配偶、父母、子女、兄弟及姊妹。
- (b) 如登記人僅由個人組成及購買 **1個**指明住宅物業：在簽署臨時買賣合約前，登記人可即時要求賣方增加簽署臨時買賣合約的人數，惟新加入之買家必須為組成登記人的**所有**個人的近親，並須提供令賣方滿意的充分證明以證明該近親關係。賣方的決定為最終決定。
- (c) 如登記人僅由個人組成及購買 **2個**指明住宅物業及登記人要求以 **1份臨時買賣合約**涵蓋所有指明住宅物業：在簽署臨時買賣合約前，登記人可即時要求賣方增加簽署臨時買賣合約的人數，惟新加入之買家必須為組成登記人的**所有**個人的近親，並須提供令賣方滿意的充分證明以證明該近親關係。賣方的決定為最終決定。
- (d) 如登記人僅由個人組成及購買 **2個**指明住宅物業及登記人要求就該些指明住宅物業簽署**多於 1份臨時買賣合約**：
- (i) 在簽署**第1個**指明住宅物業的臨時買賣合約前，登記人可即時要求賣方增加簽署該臨時買賣合約的人數，惟新加入之買家必須為組成登記人的**所有**個人的近親，並須提供令賣方滿意的充分證明以證明該近親關係。賣方的決定為最終決定。
- (ii) 在簽署**第2個**指明住宅物業的臨時買賣合約前，登記人可即時要求賣方：
- (1) 增加簽署該臨時買賣合約的人數；或
- (2) 增加簽署該臨時買賣合約的人數，及從臨時買賣合約刪除登記人的名字
- 惟新加入之買家必須為組成登記人的**所有**個人的近親，並須提供令賣方滿意的充分證明以證明該近親關係。賣方的決定為最終決定。
- (e) 所有人須以買家身份親身簽署臨時買賣合約。賣方保留其絕對酌情權允許或拒絕登記人增加及／或刪除任何人的名字的要求。
12. 當抽籤及合資格人士根據上述程序選購指明住宅物業完畢後，餘下的指明住宅物業(如有)將以先到先得形式向任何有意購買的人士發售，但每張臨時買賣合約不可涵蓋多過 2 個指明住宅物業。如有任何爭議，賣方保留絕對權力以任何方式(包括抽籤)分配任何指明住宅物業予任何有意購買的人士。為免疑問，賣方並沒有限制買方(不論個人或公司)以先到先得形式購買的指明住宅物業的數目，亦沒有限制買方為其已揀選的指明住宅物業選擇期數的相關價單中的「(E2) 70% AVD & BSD 靈活付款計劃」。
