The Vendor has absolute discretion in deciding whether a Purchaser is entitled to those discount, gift, financial advantage or benefit.   The Purchaser has settled the balance of the purchase price of the designated residential property in accordance with the agreement for sale and purchase; and

The final interest rate will be subject to approval by the designated financing company.
