(II) Procedures for Session S

- 1. Staff Registrants interested in purchasing any of the specified residential properties must follow the rules set out in the Abstract in Section (I) and the procedures specified in Section (II) of this Sales Arrangements.
- 2. Staff Registrants must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Staff Registration of Intent and **personally** attend the IFC Venue from 1:00 p.m. to 1:15 p.m. on the first date of the sale. Staff Registrants who arrive at the IFC Venue after 1:15 p.m. on the first date of the sale shall not be eligible to participate in the selection and purchase of specified residential properties using the Staff Registration of Intent during Session S. After verification of the identity of the Staff Registrants, the order of priority in which the Staff Registrants shall select and purchase a specified residential property shall be determined by the length of service of the eligible staff (in descending order) as determined by the Vendor whose determination shall be final and absolute.

All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add and/or delete the name(s) of any individual(s).
