1. General provisions:

一般規定：

1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2 In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

2. First Date of Sale:

2.1 First come first served, subject to the provisions below.

先到先得，下文另有規定除外。

2.2 All interested persons (the "Participants") who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale.

Higher priorities of selection of specified residential property(ies) will be given to the Participants with indication of intention to purchase a larger number of specified residential properties. Where two or more Participants indicates their intention to purchase specified residential property(ies) of the same quantity, balloting will be used to determine the order of priority of selection of specified residential properties among such Participants.
