1. General provisions:

1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2 In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

2. First Date of Sale:

2.1 First come first served, subject to the provisions below.

先到先得，下文另有規定除外。

2.2 All interested persons (the "Participants") who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale. Higher priorities of selection of specified residential property(ies) will be given to the Participants with indication of intention to purchase a larger number of specified residential properties. Where two or more Participants indicates their intention to purchase specified residential property(ies) of the same quantity, balloting will be used to determine the order of priority of selection of specified residential properties among such Participants.

於出售日期出售時間開始當時所有身處指定會場之有意認購的人士（下文稱作「參與人」）將被視作同時於出售日期出售時間開始當時到達。表明意欲購買指明住宅物業數量較多之參與人將獲較優先之揀選指明住宅物業次序。若兩名或以上參與人所表明意欲購買之指明住宅物業之數量相同，該等參與人之間揀選指明住宅物業之優先次序將以抽籤方式決定。

3. On the day following the First Date of Sale and thereafter:
