According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -
第52(1)條 / Section 52(1)
如某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。
A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.
第53(2)條 / Section 53(2)
如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。
If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.
第53(3)條 / Section 53(3)

- If the purchaser makes an application to the First Mortgagee for a first mortgage loan not less than 21 days before settlement of the balance of Transaction Price, no application fee will be payable in respect of the application. If the purchaser makes an application to the First Mortgagee for a first mortgage loan less than 21 days before settlement of the balance of Transaction Price, a non-refundable application fee in respect of the application in the sum of HK\$5,000 or such other amount as may be specified by the First Mortgagee from time to time is payable by the purchaser. An application should be made in writing.
