According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated;(ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

An extra 3.75% discount from the Price would be offered to a Purchaser as the Special Benefit.

(a) 代繳從價印花稅優惠 “Ad Valorem Stamp Duty” Benefit:

如買方於簽署臨時買賣合約時不選擇第(4)(ii)(c)段所述之「置業有禮」優惠，則買方可獲下述「代繳從價印花稅優惠」：

If the Purchaser does not choose the Special Benefit as set out in paragraph (4)(ii)(c) upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Ad Valorem Stamp Duty Benefit:

1. 受限於相關文件條款及條件，買方將享有「代繳從價印花稅優惠」相等於買賣合約之從價印花稅的實際金額或成交金額的 3.75%，以較低者為準。
2. 「代繳從價印花稅優惠」只作繳付買賣合約之從價印花稅之用。

Subject to the terms and conditions of the relevant document(s), the Purchaser shall be entitled to the “Ad Valorem Stamp Duty Benefit”, which is equal to the actual amount of ad valorem stamp duty payable on the agreement for sale and purchase or 3.75% of the Transaction Price, whichever is lower.
2. The “Ad Valorem Stamp Duty Benefit” shall be for the purpose of payment of the ad valorem stamp duty on the agreement for sale and purchase only.
3. If the Purchaser fails to complete the purchase of the residential property or fails to pay the balance of the Transaction Price in accordance with the terms and conditions of the agreement for sale and purchase, the Purchaser shall no longer be entitled to the “Ad Valorem Stamp Duty Benefit” and shall forthwith pay to the Vendor an amount equivalent to the “Ad Valorem Stamp Duty Benefit” previously paid by the Vendor on the Vendor’s demand.
4. All the rights and benefits conferred on the Purchaser upon the terms and conditions under this paragraph 4(iii)(a) are non-assignable and non-transferable and can only be exercised and enjoyed by the Purchaser personally.
5. For the avoidance of doubt, it is the duty on the part of the Purchaser to pay all stamp duty, including but not limited to ad valorem stamp duty, buyer stamp duty, additional stamp duty (if any) and penalty imposed by the Stamp Office (if applicable). The “Ad Valorem Stamp Duty Benefit” is only a subsidy offered by the Vendor and the Vendor shall not be liable for any delay in offering the “Ad Valorem Stamp Duty Benefit” in any event.

第一按揭貸款 First Mortgage Loan

買方可向賣方指定財務機構申請第一按揭貸款。主要條款如下:

The Purchaser can apply the First Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:

- (1) 買方必須於買賣合約內訂明的付清成交金額餘額之日或發展項目的預計關鍵日期(以較早者為準)前最少60日以書面向指定財務機構申請第一按揭貸款。
The Purchaser shall make a written application to the designated financing company for a First Mortgage Loan in not less than 60 days before the date of settlement of the balance of the Transaction Price or the estimated material date for the Development as specified in the Agreement for Sale and Purchase (whichever is earlier).
- (2) 第一按揭貸款以住宅物業之第一法定按揭作抵押。
The First Mortgage Loan shall be secured by a first legal mortgage over the residential property.
- (3) 第一按揭貸款金額最高為淨樓價80%。
The maximum amount of First Mortgage Loan is 80% of the Net Purchase Price.
