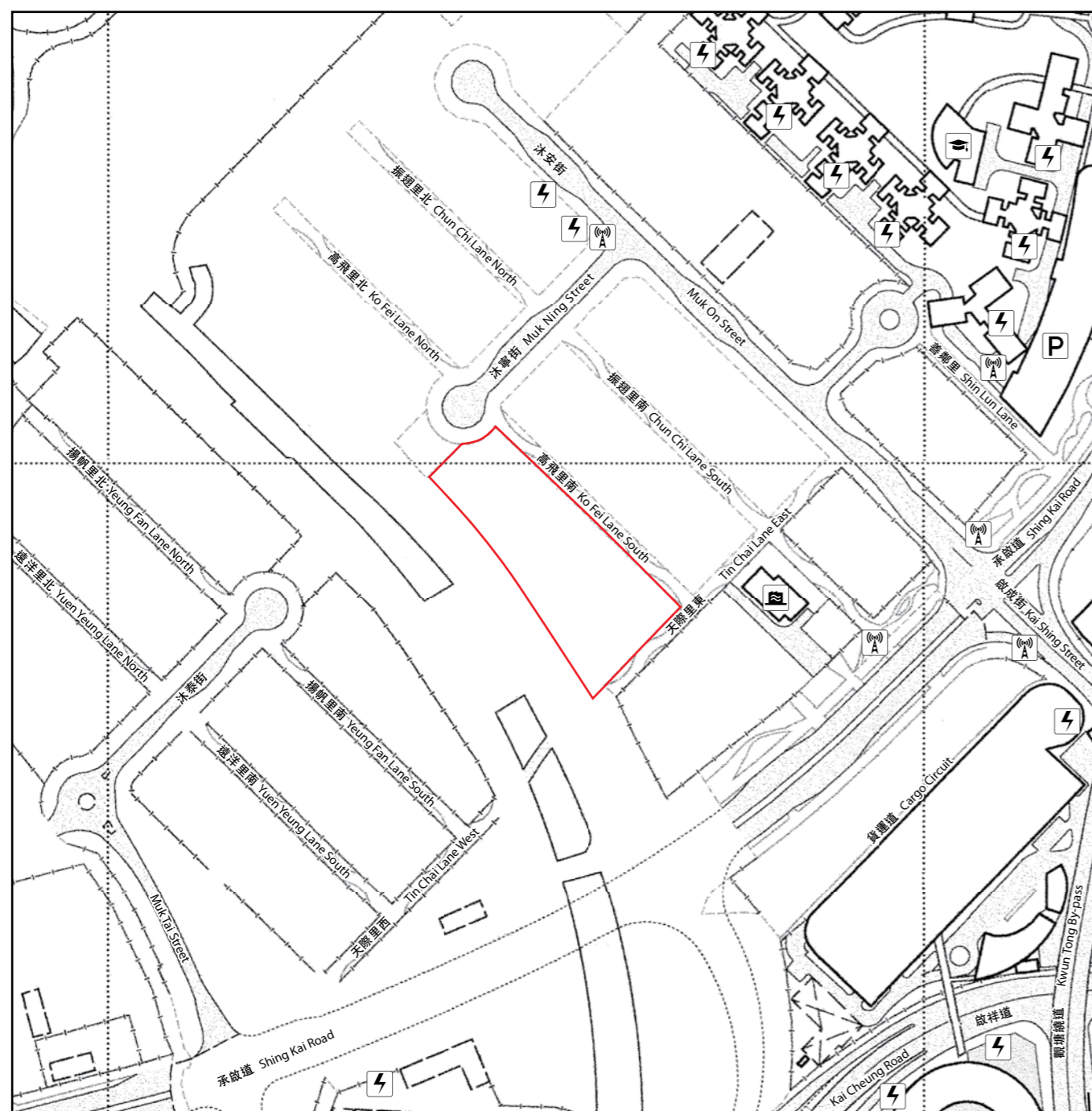

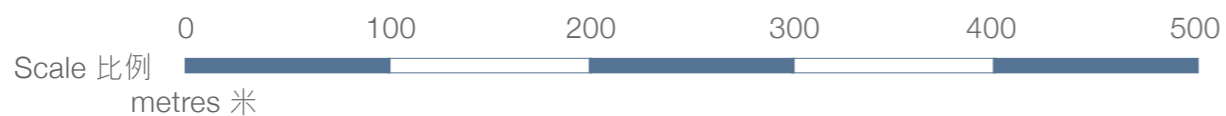
#### Notes:
