First come first served. Any person interested in purchasing any of the specified residential properties (“Prospective Purchaser”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> (a) personally attend the PARK CIRCLE Venue; and (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the Prospective Purchaser. Each cashier order shall be in the sum of HK\$200,000 and made payable to “MAYER BROWN JSM”. 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the PARK CIRCLE Venue before the commencement time of sale. 3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting). 4. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall personally enter into one or more Preliminary Agreement(s) for Sale and Purchase of the specified residential property(ies) successfully selected by him/her/it. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies). 5. The Vendor reserves the right to close the PARK CIRCLE Venue at any time if all the specified residential properties have been sold out. 6. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 8:00 a.m. and 5:00 p.m. on the first date of the sale and/or at any time between 8:00 a.m. and 5:00 p.m. on any date of sale, for the safety of the Prospective Purchasers and the maintenance of order at the PARK CIRCLE Venue, the 	

Vendor reserves its absolute right to close the PARK CIRCLE Venue. Details of the arrangement will be posted by the Vendor on the website (<http://www.parkyoho.com/venezia/en-hk>) designated by the Vendor for the Phase. Prospective Purchasers will not be notified separately of the arrangement.

1. 先到先得。任何有意購買指明住宅物業的人士（下稱「準買方」）（如準買方是公司，則其任何一位董事）須遵從下列程序：
 - (a) 親臨 PARK CIRCLE 會場；及
 - (b) 攜同其香港身份證/護照正本及本票及(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。本票的數目需與準買方將購買的指明住宅物業的數目相同，每張本票金額為港幣\$200,000 及抬頭人須為「孖士打律師行」。
2. 為決定優先次序的目的，賣方不接受出售時間開始前於 PARK CIRCLE 會場排隊輪候的人士。
3. 如有任何爭議，賣方保留絕對權力以任何方法（包括抽籤）分配該等指明住宅物業予任何有意購買的人士。
4. 成功選擇指明住宅物業的準買方（如準買方是公司，則其任何一位董事）須親身簽署一份或多份臨時買賣合約購買其成功選擇的指明住宅物業。本票將會用作支付購買指明住宅物業的部份臨時訂金。
5. 賣方保留權利在所有指明住宅物業已售出的情況下於任何時間關閉 PARK CIRCLE 會場。

<p>Other Matters: 其他事項：</p>	<p>On 13 April 2017 to 15 April 2017 (10:00 a.m. to 7:00 p.m. everyday), Prospective Purchasers are offered and invited to view the specified residential property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the specified residential property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as “Properties for Viewing”). Prospective Purchasers are reminded that the Properties for Viewing will not be made available for viewing on the first date of sale. In order to maintain order at PARK CIRCLE Venue and ensure the smoothness of the selection and purchase procedures, after a Prospective Purchaser has selected a specified residential property, the Prospective Purchaser will be required to proceed with the signing of Preliminary Agreement for Sale and Purchase of that specified residential property, and that specified residential property will not be held for the Prospective Purchaser’s viewing of any of the Properties for Viewing prior to the signing of the Preliminary Agreement for Sale and Purchase.
