The persons interested in purchasing any of the specified residential properties (“<b>the registrant(s)</b>”) must follow the procedures below:-</p> <p>1. Registrations of Intent will be distributed at Shop 8, 1/F, Crocodile Center, 79 Hoi Yuen Road, Kwun Tong, Kowloon (“<b>Sales Office 1</b>”). A registrant must submit the following:-</p>	

- (a) the Registration of Intent duly completed and signed by the registrant;
- (b) one cashier order in the sum of HK\$100,000 (if the registrant intends to purchase one specified residential property) or two cashier orders each in the sum of HK\$100,000 (if the registrant intends to purchase two specified residential properties) made payable to “Mayer Brown JSM”; and
- (c) copy(ies) of the H.K.I.D. Card(s) or Passport(s) (as the case may be) of each of the registrant;
