2. Any tender must be made in the Form of Tender (in prescribed form) which together with a Preliminary Agreement for Sale and Purchase (in prescribed form) signed by the tenderer and other relevant tender documents shall be enclosed in a sealed envelope and placed in the Tender Box located at 3A/F, New World Tower 2, 18 Queen's Road Central, Central, Hong Kong from 9:00 a.m. to 11:00 a.m. on 31 March 2017.

任何投標必須以標書（指定格式）提出，標書連同由投標者簽署的臨時買賣合約（指定格式）和其他有關的投標文件須於 2017 年 3 月 31 日上午 9 時至上午 11 時期間，放入一個密封的信封內並投入放置在香港中環皇后大道中 18 號新世界大廈 2 期 3A 樓的投標箱內。

3. If a tender is accepted by the Vendor, the Vendor shall sign the Preliminary Agreement for Sale and Purchase submitted by the successful tenderer and send a written notice of acceptance together with a counterpart of the Preliminary Agreement for Sale and Purchase duly signed by the Vendor to the successful tenderer not later than the next succeeding working day of tender closing date.

Notwithstanding anything herein provided, if typhoon signal no.8 or above is hoisted or black rainstorm warning is issued in Hong Kong at any time from 9:00 a.m. to 11:00 a.m. on the day on which the closing time of the tender falls, the closing time of the tender will automatically be postponed to 11:00 a.m. on the next succeeding working day.
