(a) 住宅停車位認購權 Option to purchase Motor Car Parking Space

購買本價單第二部分附有"*"的住宅物業的買方同時可享有不可轉讓的認購發展項目內的一個住宅停車位的權利(「認購權」),住宅停車位的售價將由賣方全權及絕對酌情決定。買方須於賣方所設定之時限及售價行使其認購權,否則其認購權將會自動失效,而買方將被視作放棄其認購權,買方並不會為此獲得任何補償。於買方行使認購權時可供購買的住宅停車位及其銷售條款與細則將由賣方全權及絕對酌情決定。此認購權僅屬於有關買方,並僅供買方享用及獲得。

At the same time when a Purchaser purchases a residential property marked with "*" in Part 2 of this Price List, the Purchaser shall have a non-transferable option to purchase ("option to purchase") one motor car parking space in the Development at the price to be determined by the Vendor at its sole and absolute discretion. The Purchaser is required to exercise his/her/its option to purchase one motor car parking space within the time limit and at the price as prescribed by the Vendor, failing which the option to purchase shall lapse automatically and be deemed to be waived by the Purchaser who shall not be entitled to any compensation therefor. The motor car parking spaces available for purchase at the time when the Purchaser exercises the option to purchase and the terms and conditions thereof shall be solely determined by and at the absolute discretion of the Vendor. This option to purchase is personal to the Purchaser and is to be enjoyed by the Purchaser only.

 - (b) 由第 37 個月起,利率以最優惠利率計算,按利率浮動而計算。
 - From the 37th month onwards, the interest shall be calculated at the Best Lending Rate, subject to fluctuation in interest rate.
- (5) 任何物業按揭貸款之提前還款(全數或部份)將須支付以下列方法計算之提前還款費:-

Any early repayment (full or partial) of the mortgage loan shall be subject to the early prepayment fee which is calculated as follows:-

 - if an early repayment in full or in part of the outstanding amount of mortgage loan, interest and other payments due and owing under the loan documentations is made within 36 months from the date of advance of the mortgage loan, no prepayment fee shall be payable;
