

If the Purchaser is unable to timely provide the official receipt(s) for payment of the relevant stamp duty due to the legislation for the proposed new rate of ad valorem stamp duty announced by the Government not being passed 60 days before the date of settlement of the balance of the purchase price or (if applicable) the estimated material date for the Phase as specified in the agreement for sale and purchase (whichever is earlier), the application shall be accompanied with the official receipt(s) for stamp duty paid and the solicitors' receipt(s) for the sum deposited by the Purchaser with the Vendor's solicitors (as stakeholders) for payment of stamp duty (including (if applicable) the ad valorem stamp duty calculated at the new rate).

The Purchaser will not be charged any handling fee or legal fee for processing the loan application. If the Purchaser shall instruct his/her/its own solicitors to act for him/her/it for the Transitional Loan, the Purchaser shall bear his/her/its own solicitors' relevant costs and disbursements.

After the Vendor has received the application and duly verified the information to be correct, the Vendor will apply the HK\$5,000 Cash Rebate for part payment of the balance of the purchase price directly.

- (c) 買方已按買賣合約付清指定住宅物業的樓價餘額。
 the Purchaser has settled the balance of the purchase price of the designated residential property in accordance with the agreement for sale and purchase.
