For the avoidance of doubt, for each purchase of a residential property, the Purchaser is only entitled to either the HK10,000 Discount as set out in paragraph (4)(SB1)(ii)5 or the Furniture Benefit as set out in paragraph (4)(SB1)(iii)5.


