From the date of sale on 10 September 2017 and thereafter, the Purchasers of any one residential unit of "Double Cove Grandview" with a saleable area of 1,453 square feet or above shall, when the Purchaser signs the Preliminary Agreement for Sale and Purchase of the said residential unit, have the right to purchase ONE of Residential Car Parking Spaces as listed in the "Price List No.1 of Parking Spaces" of Double Cove Grandview prepared by the Vendor which is available for selection at a 8% discount of the listed price(s) of the residential car parking space;
