The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

Persons interested in purchasing the above-mentioned specified residential property may purchase unit of Flat 41A (also known as Flat 61A) of the development either directly through Henderson Property Agency Limited (but not accept through other estate agents), or that person does not necessarily have to appoint any estate agent.

First-come-first-served. Persons interested in purchasing must personally attend the designated place where the sale will take place.

On 5 October 2017: Vendor does not accept any person interested in purchasing having queued up before 11:00 a.m. From 6 October 2017 and thereafter: Vendor does not accept any person interested in purchasing having queued up before the time of sale (according to the place where the sale is to take place).

But the vendor, in order to maintain order at the sales offices, reserves the right to allocate the particular specified residential property to any of the interested person and determine to whom a residential property will be sold in case of any dispute by any method (including balloting).
