(II) Procedures for Session A

1. Eligible persons interested in purchasing any of the specified residential properties that will be offered to be sold in Session A (“**Session A Registrant**”) must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (IV) of this Sales Arrangements.
2. Session A Registrant must submit the following:-
  - (a) only one Registration of Intent (Form S) (if the Session A Registrant intends to participate in Part S of Session A) and/or one Registration of Intent (Form A) (if the Session A Registrant intends to participate in Part 1 or Part 2 of Session A) duly completed and signed by the Session A Registrant. For the avoidance of doubt, a Session A Registrant (whether alone or jointly with others) must submit one Registration of Intent (Form S) and one Registration of Intent (Form A) at the same time if he/she/they intend(s) to participate in both Part S of Session A and Part 1 or Part 2 of Session A;
  - (b) Registration of Intent (Form S) shall be accompanied with one (1) cashier order. Registration of Intent

(Form A) shall be accompanied with two (2) cashier orders. Each cashier order shall be in the sum of HK\$200,000 and made payable to “Deacons”; and

- (c) a copy of the Session A Registrant’s H.K.I.D. Card(s)/Passport(s)

to ICC 21/F Venue after relevant price lists of the specified residential properties are made available till 3:00 p.m. on 24 November 2017 during office hours (i.e. from 11:00 a.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday). The closing time for submission of Registration of Intent (Form S) and Registration of Intent (Form A) will be 3:00 p.m. on 24 November 2017. Late submission or submission outside the office hours will not be accepted.

3. A list of the registration numbers and “registration timeslot(s)” of the Registration of Intent (Form S) and Registration of Intent (Form A) duly submitted in accordance with paragraph 2 above will be posted by the Vendor at the ICC 21/F Venue and 3/F, Lobby International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after 5:00 p.m on 24 November 2017. Session A Registrants will not be notified separately of the list.
4. (a) On the first date of the sale, Session A Registrant who holds a valid Registration of Intent (Form S) and/or Registration of Intent (Form A) shall **personally** (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend the ICC 11/F Venue at the “registration timeslot(s)”. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the lobby on 3/F and/or the lobby on 8/F and/or the lobby on 9/F and/or 10/F and/or 16/F and/or 21/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the “**Additional ICC Venues**”) to accommodate some of the Session A Registrants by making announcement at the ICC 11/F Venue and the Additional ICC Venues.
- (b) For the purpose of verification of identity, Session A Registrant must bring along the original receipt of the valid Registration of Intent (Form S) and/or Registration of Intent (Form A) and his/her original H.K.I.D. Card(s)/Passport(s). Session A Registrants who arrive at the ICC 11/F Venue or (if directed by the Vendor) the Additional ICC Venues beyond 9:45 a.m. on the first date of the sale shall not be eligible to participate in this Session.
5. After verification of the identity of Session A Registrants by the Vendor,
- (a) Session A will be proceeded in 3 parts and in the following order, namely, Part S, Part 1 and Part 2.
- (b) Part S, Part 1 and Part 2 of Session A
- (i) Registration Slip will be distributed at the ICC 11/F Venue and 10/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong on the first date of the sale (from 9:00 a.m. to 9:45 a.m.) (“**check-in timeslot**”). Session A Registrants who intend to participate in **Part 1 or Part 2 of Session A** must personally (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) submit only one Registration Slip duly completed and signed by the Session A Registrant to the ICC 11/F Venue or 10/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong within the check-in timeslot on the first date of the sale. The closing time for submission of Registration Slip will be 9:45 a.m. on the first date of the sale. For the avoidance of doubt, Session A Registrants who have not submitted any Registration Slip within the check-in timeslot will **NOT** be allowed to participate in Session A. Session A Registrants who intend to participate in **Part S of Session A** only shall not be required to submit any Registration Slip.
- (ii) The order of priority for selection of the specified residential properties in Part S, Part 1 and Part 2 of Session A will be determined by balloting. Separate balloting will be carried out at the commencement of Part S, Part 1 and Part 2 of Session A respectively to determine the order of priority of each Session A Registrant in selection of the specified residential properties. The following Session A Registrants will be included in the balloting of a Part of Session A:-
- Session A Registrants who have submitted a Registration of Intent (Form S) will be included in the balloting of Part S of Session A, provided that Session A Registrants who are or comprising corporations cannot participate in Session A.
  - Session A Registrants who have submitted a Registration of Intent (Form A) and indicated in their Registration Slips to participate in Part 1 or Part 2 of Session A will be included in the balloting of that Part of Session A, provided that a Session A Registrant shall only indicate to participate in either Part 1 or Part 2 of Session A and Session A Registrants who are or comprising corporations cannot participate in Session A.

- Session A Registrants who have not selected and purchased any specified residential property in Part S of Session A will **NOT** be allowed to participate in Part 1 or Part 2 of Session A unless they have also submitted Registration of Intent (Form A) and Registration Slips.
  - Session A Registrants who have not selected and purchased any specified residential property in Part 1 of Session A will **NOT** be allowed to participate in Part 2 of Session A.
  - For the avoidance of doubt, Session A Registrants who have not selected and purchased any specified residential property in any part of Session A will **NOT** be allowed to participate in Session B in their capacity as Session A Registrants.
- (iii) Every valid Registration of Intent (Form S) and every valid Registration Slip shall be allotted one lot. The results of the balloting, including “registration number” and “ballot result sequence”, will be announced and/or posted up at the ICC 11/F Venue and the Additional ICC Venues (if applicable). Session A Registrants will not be separately notified of the ballot results.
- (iv) Session A Registrants shall **personally** (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time.
- (v) The Session A Registrants shall **in compliance with the rules set out in the Abstract in Section (I) above applicable to the Part of Session A** select and purchase specified residential properties, otherwise his/her/their order of priority shall lapse automatically and he/she/they will no longer be eligible to participate in that Part of Session A.
- (vi) If the number of specified residential properties the Session A Registrant purchases in a part of Session A exceeds the number of cashier orders submitted with the Registration of Intent submitted for that part of Session A, the Session A Registrant shall submit on spot to the Vendor one cashier order for each extra specified residential property. Each cashier order shall be in the sum of HK\$200,000 and made payable to “Deacons”.
- (vii) If the remaining Session A Units available for selection and purchase in a Part of Session A is such that the rules for such Part of Session A as set out in the Abstract in Section (I) cannot be satisfied, then:-
- (in the case of Part S of Session A), Part S of Session A will end and the remaining Session A Units will be offered for sale in Part 1 of Session A;
  - (in the case of Part 1 of Session A), Part 1 of Session A will end and the remaining Session A Units will be offered for sale in Part 2 of Session A; and
  - (in the case of Part 2 of Session A), Part 2 of Session A will end and the remaining Session A Units will be offered for sale in Session B.

6. Session A Registrant who leaves the ICC 11/F Venue and/or the Additional ICC Venues (if applicable) while his/her/their sub-group is in sessions for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties and his/her/their order of priority shall lapse immediately.

7. If the Session A Registrant has successfully selected any of the specified residential properties in compliance with the rules set out in the Abstract in Section (I), the Session A Registrant shall **personally** (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) enter into one or more Preliminary Agreement(s) for Sale and Purchase of the selected specified residential properties.

8. Prior to the signing of the Preliminary Agreement for Sale and Purchase, Session A Registrant who has selected **only one** specified residential property may notify the Vendor on spot to add individual(s), provided that the additional individual(s) must be the **close relative(s)** (i.e. spouse, parents, children, brothers and sisters) of ALL the individual(s) comprised in the Session A Registrant and subject to the provision of adequate proof of such relationship(s) to the Vendor’s satisfaction whose determination shall be final.

9. Prior to the signing of the Preliminary Agreement for Sale and Purchase, Session A Registrant who has selected **more than one** specified residential property may notify the Vendor on spot to add and/or delete individual(s) signing the Preliminary Agreement(s) for Sale and Purchase, but subject to the following:

- (a) the Session A Registrant will not be allowed to first delete and then add individual(s) signing the Preliminary Agreement for Sale and Purchase;
- (b) if a Session A Registrant wishes to add any individual(s), then prior to adding of any individual(s) all the

individual(s) comprised in the Session A Registrant must be **close relative(s)** (i.e. spouse, parents, children, brothers and sisters) of each other and the additional individual(s) must be the **close relative(s)** of **ALL** the individual(s) comprised in the Session A Registrant and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final;

- (c) if a Session A Registrant wishes to delete any individual(s), then prior to deletion of any individual(s) all the individual(s) comprised in the Session A Registrant must be the **close family member(s)** (i.e. spouse, parents, children, brothers, sisters, grandparents and grandchildren) of each other and subject to the provision of adequate proof of such relationship to the Vendor's satisfaction whose determination shall be final.

10. All the person(s) signing the Preliminary Agreement(s) for Sale and Purchase shall sign personally (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) as purchaser. The Vendor reserves its absolute discretion to allow or reject the Session A Registrant's request to add and/or delete any individual(s).

**(III) Procedures for Session B**

11. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any of the specified residential properties that will be offered to be sold in Session B ("**Session B Registrant**") must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (III) and (IV) of this Sales Arrangements.

12. The Vendor may postpone the commencement of Session B pending completion of Session A. Session B Registrants will not be separately notified of such change.

13. Session B Registrant must submit the following:-

- (a) only one Registration of Intent (Form B) duly completed and signed by the Session B Registrant;
- (b) Registration of Intent (Form B) shall be accompanied with cashier order(s). The number of cashier order(s) shall equal to the number of specified residential properties which Session B Registrant intends to purchase as indicated in the Registration of Intent (Form B), but in any event shall not exceed 2. Each cashier order shall be in the sum of HK\$200,000 and made payable to "Deacons"; and
- (c) a copy of the Session B Registrant's H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to ICC 21/F Venue after relevant price lists of the specified residential properties are made available till 3:00 p.m. on 24 November 2017 during office hours (i.e. from 11:00 a.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday). The closing time for submission of Registration of Intent (Form B) will be 3:00 p.m. on 24 November 2017. Late submission or submission outside the office hours will not be accepted.

14. Balloting will take place in batches:-

- (a) First round balloting for this Session (for dividing all Session B Registrants into one or more sub-group(s))

- (i) The first round balloting for this Session will take place at or after 5:00 p.m on 24 November 2017 at the ICC 21/F Venue for the purposes of dividing the Session B Registrants into one or more sub-group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 21/F Venue and/or facilitating smooth operation of the balloting procedures, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the ICC 21/F Venue. Session B Registrants will not be notified separately of such changes.

- (ii) The results of the first round balloting, including "registration number", "division of sub-group", "check-in timeslot for each sub-group" will be posted by the Vendor at the ICC 21/F Venue and 3/F, Lobby International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong after completion of the first round balloting. Session B Registrants will not be separately notified of the ballot results.

- (b) Second round balloting (for determining the order of priority of Session B Registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting for the sub-group(s) of Session B Registrants will take place on 25 November 2017 in batches at the ICC 11/F Venue at the beginning of the relevant "check-in timeslot for each sub-group" as posted by the Vendor pursuant to sub-paragraph (a)(ii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 11/F Venue

and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the ICC 11/F Venue. Session B Registrants will not be notified separately of such changes.

- (ii) For the purpose of verification of identity, Session B Registrants must bring along the original receipt of the valid Registration of Intent (Form B) and his/her/its/their original H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and the original H.K.I.D. Card(s)/Passport(s) of all of the director(s) and (if the Session B Registrant comprises corporation, then all directors of that corporation) **personally** (or pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend the ICC 11/F Venue according to “check-in timeslot for each sub-group” posted by the Vendor.
