The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <a href="Prospective Purchaser">Prospective Purchaser</a>. Each cashier order shall be in the sum of HK\$100,000 and made payable to "MAYER BROWN JSM".
- 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the PARK CIRCLE Venue before the commencement time of sale.
- 3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).
