Subject to the provisions set out in “Other matters”, first come first served. Persons interested in purchasing (or their attorneys pursuant to a validly executed power of attorney in a form prescribed by the Vendor) must personally attend the designated venue to select the residential property(ies) that the person wishes to purchase. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.
