Subject to the provisions set out in “Other matters”, first come first served. Persons interested in purchasing (<i>or their attorneys pursuant to a validly executed power of attorney in a form prescribed by the Vendor</i>) must personally attend the designated venue to select the residential property(ies) that the person wishes to purchase.
