第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如買方於簽署臨時買賣合約時不選擇第(4)(ii)(c)段所述之「置業有禮」優惠，則買方可獲下述「代繳從價印花稅優惠」：
If the Purchaser does not choose the Special Benefit as set out in paragraph (4)(ii)(c) upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Ad Valorem Stamp Duty Benefit:

(d) 第一按揭貸款及第二按揭貸款 First Mortgage Loan and Second Mortgage Loan:

In particular, no warranty or representation whatsoever is given as to the physical condition and state, quality or the fitness of any of the furniture and chattels or as to whether any of the furniture and chattels are or will be in working condition). The furniture and chattels will be delivered to purchaser upon completion on an "as is" condition.
