The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

First come first served, subject to the provisions below.

All interested persons (or their attorneys) who are present in the Sales Office as at the beginning of the Time of the Sale will be regarded as all having come to the Sales Office at the same time at the beginning of the Time of the Sale.

Such persons will be grouped into three groups (each a “Group”) and any person in the Group will be referred to as a “Group Participant”) according to the number of specified residential properties such persons intend to purchase of determining the order of priority in selection of specified residential properties.

於出售時間開始當時所有身處售樓處之有意購買之人士(或其授權人)將被視作同時於出售時間當時到達。該等人士將按其意欲購買指明住宅物業之數量分為三組（「組別」，歸入組別的人士稱作「組別參與人」），以決定揀選指明住宅物業的優先次序。

The priorities in the selection of specified residential properties among the Groups are as follows:

Balloting will be used to determine the order in priority in selection of those specified residential properties among such Group Participants within each Group. Each such Group Participants shall be allotted with one lot. The balloting results will be announced by means as the Vendor considers appropriate at the Sales Office. The Group Participants concerned will not be separately notified of the balloting results.

The following provisions apply to the selection of specified residential properties in the Groups:

(b) Where a Group Participant selects more than one specified residential property:

- (ii) the Purchaser of each other so selected specified residential property shall only be:

 - (4) the Group Participant together with one or more “Immediate Family Members” of that Group Participant whom that Group Participant requests the Vendor on spot to add as joint purchaser(s); or
該組別參與人連同該組別參與人即場向賣方要求加入作為聯名買方之該組別參與人之一位或多位「直系親屬」；或
 - (5) one or more persons comprising that Group Participant (“the Remaining Participant”) together with one or more “Immediate Family Members” of the Remaining Participant whom the Remaining Participant requests the Vendor on spot to add as joint purchaser(s).

Provided That the Purchaser (or one of the persons comprising the Purchaser) of each of such so selected specified residential properties shall be the same person or an “Immediate Family Member” of the Purchaser (or one of the persons comprising that Purchaser) of any other so selected specified residential property.

- (c) “Immediate Family Member” of a Group Participant or the Remaining Participant (as the case may be) means a spouse, parent, child or sibling of that Group Participant or any individual comprising that Group Participant or of that Remaining Participant or any individual comprising that Remaining Participant (as the case may be) Provided That the Group Participant or the Remaining Participant (as the case may be) has provided the relevant supporting documents to the satisfaction of the Vendor to prove the relationship.

- (a) The sale of the residential properties is subject to availability. Also, the Vendor reserves the right to suspend sales or reduce the number of properties to be offered for sale at any time. Please note that the Vendor's admittance of any person to the waiting queue does not guarantee that the person will be able to purchase any residential property.

- (b) The Vendor does not accept any corporate potential purchaser which is not incorporated in Hong Kong (where the potential purchaser comprises more than one person and any such person is a corporation which is not incorporated in Hong Kong, that potential purchaser will be regarded as a "corporate potential purchaser which is not incorporated in Hong Kong") purchasing any residential property covered by this Information on Sales Arrangements. For the avoidance of doubt, the aforesaid restrictions apply on 9 February 2018 and thereafter.
