The purchaser shall make a written application to the vendor for a second mortgage loan not less than 60 days before the date of intended settlement of the balance of the transaction price.

The Purchaser can exercise his/her/its option in accordance with the time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

The Option is not transferrable. The Option is subject to the actual number of residential parking spaces available for sale in the Development. The Vendor gives no warranty that one residential parking space can be purchased in respect of each Option. The Vendor shall not be liable for any compensation to the holder of any Option even if no residential parking space can be purchased in respect of the Option. In case of any dispute, the Vendor reserves its absolute right to allocate any residential parking space to any interested person (including without limitation by way of balloting).

The Vendor reserves its absolute right to stop providing any Option at any time without notice and the holder of any Option shall not be entitled to any compensation therefor
