The purchaser shall make a written application to the vendor for a second mortgage loan not less than 60 days before the date of intended settlement of the balance of the transaction price.

The Purchaser shall provide sufficient documents to prove his/her repayment ability, including but not limited to providing sufficient documents (for example latest 3 years' Tax Assessment and Demand Note or Profits Tax Assessment and Demand Note and latest 6 months' bank book/statements which show salary deposits or income) to prove that the total amount of monthly installment (being the total installment for repayment of first mortgage, second mortgage and any other loan repayment) does not exceed the maximum debt-servicing ratio as stipulated by the Hong Kong Monetary Authority from time to time.

Irrespective of whether the loan is granted or not, the purchaser shall complete the sale and purchase in accordance with the ASP and pay the full transaction price.

For the avoidance of doubt, this paragraph (4)(iii)(c)(A) does not restrict the entitlement of any Purchaser who is a company to the Option.

Any Purchaser who have purchased two (2) or more specified residential properties on the same day (whether under the same preliminary agreement for sale and purchase or otherwise), of which any one must be a 3-bedroom (or above) unit, shall have an option to purchase one residential parking space in the Development for every two (2) specified residential properties (comprising at least one (1) 3-bedroom (or above) unit) so purchased. The Purchaser can exercise his/her/its option in accordance with the time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

The Option is not transferrable. The Option is subject to the actual number of residential parking spaces available for sale in the Development. The Vendor gives no warranty that one residential parking space can be purchased in respect of each Option. The Vendor shall not be liable for any compensation to the holder of any Option even if no residential parking space can be purchased in respect of the Option. In case of any dispute, the Vendor reserves its absolute right to allocate any residential parking space to any interested person (including without limitation by way of balloting).

  - are subject to the sole discretion of the Vendor.
- (E) 賣方保留最終決定權在任何時候隨時停止提供任何認購權而無須另行通知,任何認購權持有人不會為此獲得任何補償。 The Vendor reserves its absolute right to stop providing any Option at any time without notice and the holder of any Option shall not be entitled to any compensation therefor.
