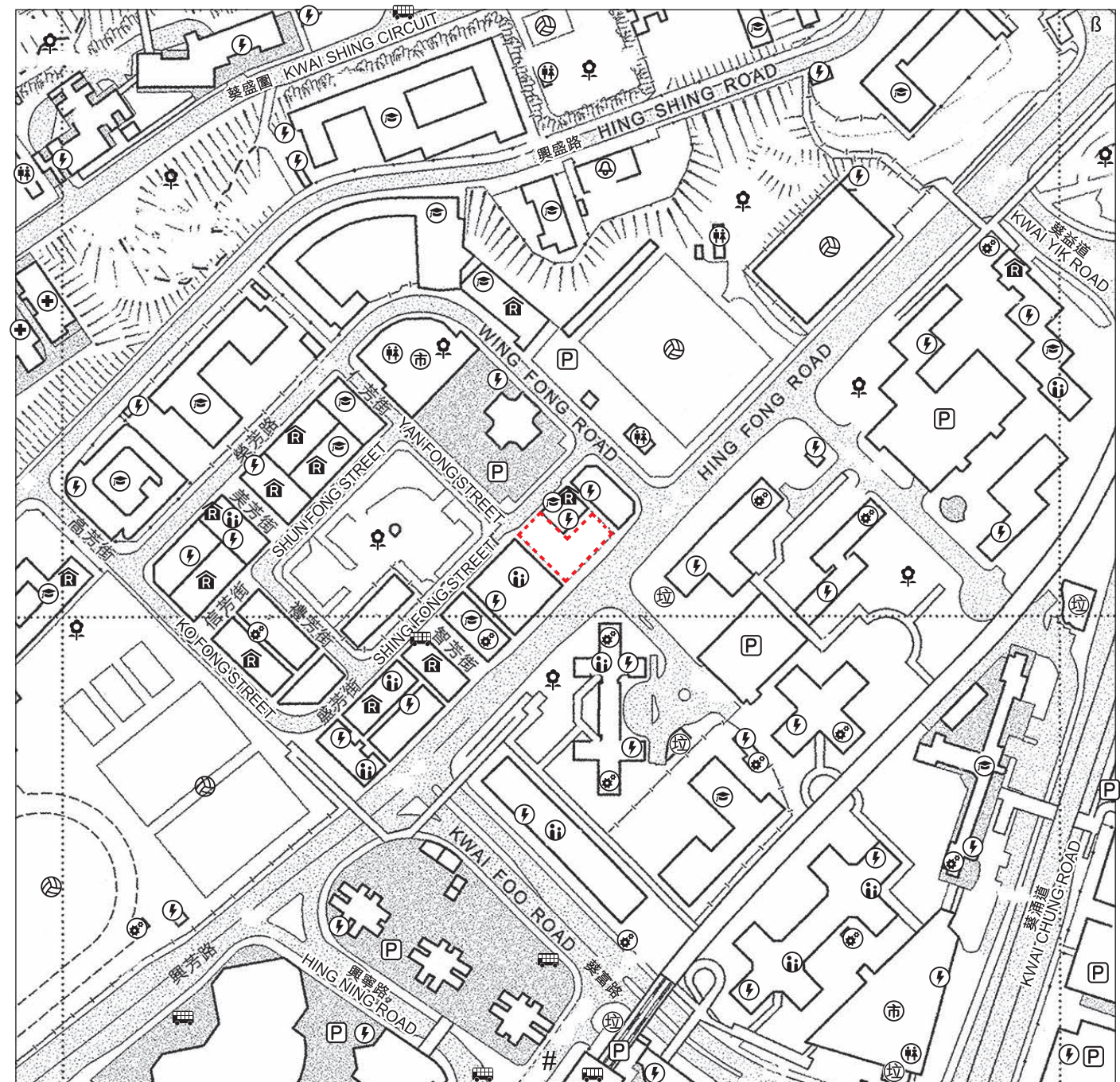


LOCATION PLAN OF THE DEVELOPMENT
