The Vendor will pay the "Park Mediterranean Eminent Family Cash Rebate" to the Purchaser in such manner as the Vendor may decide within 60 days after the Vendor has received the application and duly verified the fulfillment of all the above conditions by the Purchaser and the Related Purchaser(s) and the information. The benefit is subject to other terms and conditions.
