The decision as to whether and when to sell any Residential Parking Space and the terms of such sale are subject to the sole discretion of the Vendor.

(d) Quintessentially Lifestyle 尊貴級別會籍1年 Quintessentially Lifestyle Dedicated Annual Membership for 1 year
