




FLOOR PLAN 平面圖



GROUND FLOOR PLAN 地下平面圖












2<sup>ND</sup> FLOOR PLAN 2 **樓平面圖**




GROUND FLOOR PLAN 地下平面圖




GROUND FLOOR PLAN 地下平面圖


