The Residential Parking Space available for purchase and the terms and conditions of the sale and purchase thereof shall be determined by and at the sole and absolute discretion of the Vendor. The relevant residential property and the Residential Parking Space selected and purchased by the Purchaser shall both be included in and subject to the same preliminary agreement for sale and purchase, agreement for sale and purchase and subsequent assignment.

(b) 「備用按揭貸款」"Standby Mortgage Loan"

The Purchaser may apply for a first mortgage loan ("mortgage loan") from a lender company designated by the Vendor (the "Lender"), such mortgage loan application shall be made by the Purchaser to the Lender in the prescribed written form no later than 30 days before the intended date of advance of the mortgage loan and shall be approved by the Lender. Whether the application is approved or not is subject to the final decision of the Lender. This mortgage loan is subject to the following main terms and conditions: -

Such furniture and chattels will be delivered to the Purchaser upon completion in such condition as at completion together with these Flat A on the 11th Floor of Tower 2 and/or Flat B on the 11th Floor of Tower 2 (as the case may be). In any event, no objection or requisition whatsoever shall be raised by the Purchaser in respect of such furniture and chattels. This offer is subject to other terms and conditions.
