Standby Second Mortgage Loan (Only applicable to a specified residential property marked with a "@" in this price list)

買家可向 Harbour Horizon Limited 或賣方指定的其他公司(統稱「賣方指定的財務機構」)申請備用二按貸款(賣方或賣方指定的財務機構有權隨時停止提供備用二按而無須另行通知)，主要條款如下：

The Option is not transferrable. The Option is subject to the actual number of Residential Parking Spaces available for sale in the Development. The Vendor gives no warranty that one Residential Parking Space can be purchased in respect of each Option. In case of any dispute, the Vendor reserves its absolute right to allocate any Residential Parking Space to any interested person (including without limitation by way of balloting). Price List(s) and sales arrangements details of Residential Parking Spaces in the Development will be determined by the Vendor at its sole and absolute discretion and will be announced later. The decision as to whether and when to sell any Residential Parking Space and the terms of such sale are subject to the sole discretion of the Vendor.
