If the Purchaser has any objection or requisitions whatsoever in respect of the Furniture, the Purchaser shall contact designated furniture provider directly. For the avoidance of doubt, the First 3 Years Warranty Offer as set out in paragraph (4)(B4)(iii)6 does not apply to the Furniture.

The Purchaser will not be charged any handling fee or legal fee for processing the loan application. If the Purchaser shall instruct his/her/its own solicitors to act for him/her/it for the Transitional Loan, the Purchaser shall bear his/her/its own solicitors' relevant costs and disbursements.

After the Developer has received the application and duly verified the information to be correct, the Developer will apply the HK\$5,000 Cash Rebate for part payment of the balance of the purchase price directly.

The above-mentioned “connected family member” refers to spouse, parents, children, brothers, sisters, grandparents or grandchildren.

The above-mentioned “related residential property” refers to The Wings, The Wings II, The Wings IIIA, The Wings IIIB, Ocean Wings, East Point City, Oscar By The Sea, Ocean Shores or Park Central.

The Purchaser shall apply to the Developer in writing for the TKO Life Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price of the residential property or (if applicable) the estimated material date for the Phase as specified in the agreement for sale and purchase of the residential property (whichever is earlier) and shall provide documentary evidence to prove (if applicable) the “connected family member” relationship mentioned in paragraph (I) above and (if applicable) the stamped formal tenancy agreement of the related residential property to the Developer’s satisfaction and in this respect the Developer shall have absolute discretion and the

Developer's decision shall be final and binding on the Purchasers. After the Developer has received the application and duly verified the information to be correct, the Developer will apply the TKO Life Cash Rebate for part payment of the balance of the purchase price of the residential property directly.

- (IV) TKO Life現金回贈受其他條款及細則約束。  
The TKO Life Cash Rebate is subject to other terms and conditions.
