The above-mentioned "connected family member" refers to spouse, parents, children, brothers, sisters, grandparents or grandchildren.

The Purchaser shall apply to the Developer in writing for the TKO Life Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price of the residential property or (if applicable) the estimated material date for the Phase as specified in the agreement for sale and purchase of the residential property (whichever is earlier) and shall provide documentary evidence to prove (if applicable) the "connected family member" relationship mentioned in paragraph (I) above and (if applicable) the stamped formal tenancy agreement of the related residential property to the Developer's satisfaction and in this respect the Developer shall have absolute discretion and the



Developer's decision shall be final and binding on the Purchasers. After the Developer has received the application and duly verified the information to be correct, the Developer will apply the TKO Life Cash Rebate for part payment of the balance of the purchase price of the residential property directly.
